8. If blasting occurs within 2,000 feet of structures or facilities, a Pre-Blast assessment must be submitted
9. Other information deemed necessary by the Fire Marshal's Office may include: Pre-Blast inspections, Hydrological Study, Geological Study, and Test Wells.
