A Public Review Meeting will be held on Thursday, September 23, 2021 at 11:00 a.m. to receive comments on the draft 2022 Annual Action Plan and CDBG, HOME, and ESG funding

recommendations.

A 30-day public comment period commences on Friday, September 10, 2021 and will conclude on Wednesday, October 13, 2021.

The proposed recommended funding allocations and the draft 2022 Annual Action Plan will be included on the Tuesday, November 9, 2021 Board of Commissioners' Agenda.
