WHEREAS, in 2020, the General Assembly passed and the Governor signed HB786, creating an 11th Judgeship for the Cobb Judicial Circuit for a term beginning January 1, 2022.

AND WHEREAS, the data demonstrates that a new judgeship for the Cobb Judicial Circuit will increase Cobb's capacity to handle criminal, civil, and domestic matters, ensuring that cases are disposed of effectively and efficiently and that justice continues to be administered fairly and impartially.

AND WHEREAS, the Cobb Judicial Circuit is best served by judicial caseload distribution that fairly and equitably balances the workload of each judge, consistent with Uniform Superior Court Rule 3.2, insofar as is practical.

NOW, THEREFORE, IT IS ORDERED, that a random selection of civil and criminal cases equal to the median number of open criminal and civil cases between the ten (10) current judges be designated for transfer. The designation protocol shall provide that each judge shall have an equal number of cases designated for transfer and that each judge shall, as much as is practically possible, have an equal number of serious felony, felony, misdemeanor, general civil, and domestic relations cases designated for transfer. Standard rounding rules shall be applied if needed during the designation.

IT IS FURTHER ORDERED, that upon receipt of this Order, the Clerk of Superior Court shall assign the cases identified in Appendices "A" (Judge Mary Staley Clark), "B" (Judge Robert E. Flournoy III), "C" (Judge C. LaTain Kell), "D" (Judge Robert D. Leonard II), "E" (Judge A. Gregory Poole), "F" (Judge Ann B. Harris), "G" (Judge Kimberly A. Childs), "H" (Judge Kellie S. Hill), "I" (Judge Angela Z. Brown), and "J" (Judge Jason D. Marbutt) of this Order to Judge Henry R. Thompson without further order or intervention from the currently assigned judge. The Clerk shall assist in rescheduling the cases designated in the Appendices and take any other necessary steps to ensure an efficient and effective transition of said cases.

IT IS FURTHER ORDERED, that no later than January 1, 2022, at 8:00 AM, said case transfers shall be completed. No further orders from the previously assigned judges shall be necessary to perfect the transfers, and the cases shall be assigned to Judge Henry R. Thompson for disposition.

IT IS FURTHER ORDERED, that pursuant to the Superior Court's Case Assignment Order, on January 1, 2022, Judge Henry R. Thompson shall be considered a "Judge of this Court" for purposes of randomly assigning newly filed cases.

IT IS FURTHER ORDERED, that the Magistrate Court reassign unindicted criminal warrants in a manner consistent with the protocol outlined above provided that each judge shall have reassigned, as much as is practically possible, the same number of unindicted criminal warrants from each category of the Magistrate Court Disclosure Statement.
