## Munchkin Camp (ages 3-5 years old) 8:45 a.m. to 9:30 a.m. Cost: \$35.00 for the week.

This is an introduction to tennis class for beginners or advanced beginner children. We work on handeye coordination, basic tennis strokes and play a lot of fun games. Camp participants should bring a tennis racquet, water or sports drink. Dress appropriates for an athletic activity and wear sunscreen.

This group is for tournament players only. High level drills and point development emphasized. Plyometrics, dynamic stretching introduced to players. We will also have match play each day where we work on strategy.
