## COBB COUNTY WATER SYSTEM FIRE HYDRANT METER RENTAL AGREEMENT

On this the \_\_\_\_\_ day of \_\_\_\_\_, 20\_\_\_\_, this agreement between the Cobb County Water System (CCWS) and \_\_\_\_\_ (Contractor) is entered into for the following fire hydrant meter:

Whereas, Contractor desires that the referenced fire hydrant meter be made available for the sole purpose of obtaining water service from available Cobb County Water System fire hydrants.

In consideration of the mutual agreement and promises contained herein, Contractor agrees as follows:

1. The Contractor shall be responsible for said meter and damages thereto, considering normal use.
2. The Contractor shall be responsible for payment of all fees accumulated, including but not limited to the daily rental fee, until the meter is returned to the CCWS offices and rental agreement terminated.
3. **The meter should be returned to CCWS promptly upon completion of the work for which it is utilized; however, the meter must be returned within 365 calendar days from the date it is rented.**
4. **If the meter is lost, stolen, or otherwise not returned**, the Contractor shall be responsible for the cost of the lost/stolen equipment plus the daily rental fee and estimated usage of 500 gal/day accumulated until CCWS is notified and rental agreement is terminated.
5. The Contractor agrees that the rates and fees in effect at the time of meter return shall be used to calculate amount due from water consumption. The initial security deposit for this meter will be held until the meter is returned. Upon return, all applicable rates and fees will be calculated and deducted from the deposit.
6. The Contractor agrees to utilize and install the meter and related equipment in accordance with instructions given verbally by CCWS and the written instructions provided to Contractor's Representative. **The usage will be estimated at 500 gal/day on meters returned with negative consumption.**
7. The fire hydrant meter rental fees and instructions are available on the CCWS website at <https://www.cobbcounty.org/water/customer-service/fire-hydrant-meter-rental>.
8. Use of a Cobb County fire hydrant inconsistent with the terms and conditions of this agreement constitutes a felony.
