

### **Irrevocable Online Riding Lessons and Equi- Chair Waiver Form**

In consideration of being allowed to participate in the online horseback riding lessons with Susanne von Dietze-Pollak:

I attest for myself and/or any minor children for whom I am parent, legal guardian, or otherwise responsible and for my/our heirs, personal representatives or assigns, hereby irrevocably acknowledge the risks of injury or damage (to property, personal injury and/or death) involved in participating in online riding lessons, being around and/or touching a horse. I understand that there is a risk in riding and being near live animals and acknowledge that my/our participation in this activity is purely voluntary.

I further understand that an online coach cannot assess the surroundings, the surrounding circumstances or my horse and is relying solely on my personal assessment regarding safety and any risk incurred to myself, the horses or the surroundings as described above.

I irrevocably assume full responsibility for myself and/or any minor children for whom I am parent, guardian or otherwise responsible, for any bodily injury, accident, illness, paralysis, death, loss of personal property and expenses thereof arising as a result of any accident which may occur while I/we participate in any of the online riding lessons.

I attest that I/we participating in the activity. further agree to abide all safety instructions hereby irrevocably release, acquit and forgive Susanne von Dietze-Pollak from any and all liability of any nature for any and all injury or damage (including property damage, personal injury, illness, paralysis, and/or death) to me or said minor children and other persons as well as animals as the result of my/our participation in the online riding lessons.

I attest for myself and/or any minor children for whom I am parent, legal guardian, or otherwise and for my/our heirs, personal representatives, or assigns, hereby irrevocably release, acquit Susanne von Dietze-Pollak, her principals, officers, agents, employees, and volunteers ("Releases") from any and all liability of for any and all injury or damage (including property damage, personal injury, illness, and/or death) to me or said minor children and other persons as well as animals as the result of my/our online riding lessons.

I attest for myself and/or any minor children for whom I am parent, legal guardian or otherwise responsible, and for my/our heirs, personal representatives or assigns, also hereby irrevocably and expressly waive any claim, lawsuit, complaint, charge, or cause of action against Susanne von Dietze-Pollak. her principals, directors, agents, employees and for any and all injury or damage including property damage, personal injury, illness, paralysis and/or death, to me and/ or any such minor children and other persons or animals as a result of my/our participation in online riding lessons.
