STEWARDSHIP: THE ORGANIZATION ACTIVELY STEWARDS ITS CONSERVATION PROPERTIES. THE ORGANIZATION PREPARES A MANAGEMENT PLAN FOR ALL OF ITS FEE TITLE LANDS AND A BASELINE DOCUMENT REPORT FOR ALL OF ITS CONSERVATION EASEMENTS. THESE DOCUMENTS GUIDE ITS ANNUAL WORK PLANS IN SUPPORT OF THE CONSERVATION VALUES OF THE LANDS.

THE TRUST HOLDS 2,375 ACRES OF CONSERVATION LAND IN FEE TITLE AND 42 CONSERVATION EASEMENTS PROTECTING 3,261 ACRES. FOR FEE TITLE PROPERTIES, THE ORGANIZATION PROVIDES HABITAT PROTECTION AND RESTORATION, INCLUDING SPECIES MONITORING, GRAZING, FOREST MANAGEMENT, RESEARCH AND EDUCATION. FOR THE CONSERVATION EASEMENTS, THE ORGANIZATION MONITORS THE VALUES OF THE EASEMENT AND PROTECTS AGAINST
