DEPARTMENT HEAD/COUNCIL COMMITTEE/BOARD/COMMISSION REPORT

ORDINANCE 2021-8 – SECOND READING

An Ordinance of the Town of Eatonville, Washington, approving a site-specific rezone for the real property located at 331 and 333 Washington Ave N and amending the Eatonville zoning map by changing the zoning classification for the property from Multi-Family Residential District (MF-1) to Downtown Commercial District (C-1).

Town Clerk Miranda Doll read the Ordinance by title into the record.

Councilmember Dunn made a motion to approve the second reading of Ordinance 2021-8 and was seconded by Councilmember McFadden. All were in favor.

SETTING PLANNING COMMISSION AGENDA FOR OCTOBER 18, 2021

Councilmember McFadden made a motion to approve the agenda as presented and was seconded by Councilmember Dunn. All were in favor.

RESOLUTION 2021-KK

A Resolution of the Town of Eatonville, Washington, approving with conditions a preliminary plat for a subdivision known as Lynch Creek Landings.

Town Clerk Miranda Doll read the Resolution by title into the record.

Councilmember Dunn made a motion to approve Resolution 2021-KK and was seconded by Councilmember McFadden. Motion passed 3-1.

COUNCIL MEMBER COMMENTS

Councilmember McFadden let the Council know why she voted the way she did on the Resolution, she feels it's a tough call to add requirements that are not set in code.

Councilmember Dunn extended his condolences to Councilmember Walter for his loss.

Councilmember Thomas thanked Chief LaLiberte for taking care of the traffic issue on Lynch Creek Rd.

Councilmember Hannah apologized for her recent absences and gave her deepest condolences to Councilmember Walter for the loss of his wife Dixie.
