Management Activities



Eatonville has experienced an uptick (200%) in commercial theft/burglary cases which is consistent with the surrounding unincorporated Pierce County areas. It is my opinion; the suspects are figuring out the restrictions law enforcement officers are facing due to the new legislative reform laws. Theft (misdemeanor or felony) and burglary are no longer crimes that officers can engage in a vehicle pursuit for.



General

The meeting went efficiently. We got through our agenda items.

Current Tasks

1. Short Term Rentals

We had great discussions about the effects short term rentals have on communities and neighborhoods. We talked at length about examples of that and how it could affect Eatonville as a whole. We are now doing our due diligence and researching how other municipalities that are similar in size and in Washington have handled this issue and what the ratio of rental properties to home owners is in Eatonville so we can make an informed decision and well thought out code suggestion to the council for their consideration since there is currently no language in the Eatonville Municipal Code concerning anything about short term rentals.

2. Sign Code Review

We talked about the history and reason behind beginning this work on behalf of the council since this hasn't been something that the town has taken up since before the pandemic. We believe that our task before us is to consider, research and present a code suggestion to the attorney for review and to you for your consideration and approval. If that is not it, please let us know. We did have a question though. Are we supposed to be looking only at the sections related to the Supreme Court case Reed v.

Gilbert mentioned to us or are we to be reviewing the entire sign code as a whole? Thank you.

SOUTH PIERCE FIRE AND RESCUE

- SPFR continues with mediation meetings on the reorganization and testing processes with L-726.
- SPFR has an ongoing in-house Volunteer Academy. All recruits are doing well and we just completed Live Fire training.
- SPFR new fire engine is in the Portland area receiving its final inspection and outfitting. It is projected to be in service in early December. The "Push in" ceremony date at Station #170 is TBD.
- SPFR is in the process of running an In-House testing process to fill three firefighter/EMT positions. These firefighters will come on board in January and go directly to the Bates Technical College Fire Academy. This will bring the department to full staffing on all shifts
