General

The meeting went efficiently. We got through our agenda items.

Current Tasks

We started off the meeting asking Commissioner Baublits to reiterate the email conversation he had with the town attorney regarding whether guidelines or codified "in code" language are good and efficient ways to propose legislation to the council and the merits of each which led into the short term rentals discussions.

1. Short Term Rentals

We had discussions, along with Mr. Scott Clark, town planner, Mr. Jacoby and the other commission members about fees, taxability and zoning of short term rentals. We looked briefly at where code could be placed regarding the regulation of short term rentals. Mr Baublits provided us a draft to go over that he came up with that could be used to regulate short term rentals. It needs work but we are getting closer to having a working document to go over and make edits to. Stay tuned.

2. Sign Code Review

We decided to zero in on Ellensburg's code as being a good model to look at, edit and send your way for recommendation. We received guidance from Scott Clark and Mr Jacoby that contact be made with the planners at Ellensburg regarding their sign code and whether or not they adjusted their code to conform to the Supreme Court's decision in 2015. We will wait to hear back from Mr. Clark.

3. Additional Review of Title 19

- 1. We had a surprise visit by two council members to help guide our next discussions about Title 19 and look forward to looking at the main sections they had questions with and where they want further edits to happen. We had further discussions about timetable language and whether that should be edited for council consideration. It led generally about how the code needs a big revision where sections seem out of place when they belong in other places in the code as a whole. Scott Clark, council member Thomas, and Mr. Jacoby suggested that we take a good look at the pertinent sections of the Comprehensive Plan to guide us in these discussions. Mr Clark is going to be making changes and edits to the copy we voted on and sent you.
- 2. Aerospace District: Regarding Title 19 and the aerospace district, we decided to research municipalities about how they handle design decisions at municipal airports.

- Congratulations to Volunteer FF Gunnar Lambrecht for receiving and accepting a career firefighter position at West Pierce Fire & Rescue
- SPFR has taken delivery of a new Spartan Fire Engine. We are currently completing inservice training and with a "Push in" ceremony date at Station #170 is TBD

She is a quick study and brings with her a plethora of new ideas and innovations for our Department. Please stop in and meet her when you have an opportunity.

Eatonville continues to experience a consistent but leveled out number of incidents of commercial and private theft/burglary cases which are consistent with the surrounding unincorporated Pierce County areas. We are targeting specific areas of vulnerability and our officers are aware of, and have reacted to, the need for increased proactiveness.

Our community outreach/Safe Streets forum on November 10th was a success with over 30 attendees on Zoom. Several sub-communities have reached out and followed up with Safe Street to organize independent block watch groups.




In November 2021- EPD had 159 total calls for service.

- Daily Water and wastewater treatment quality assurance / quality control laboratory testing
- Daily pick up garbage in parks
- Daily water and wastewater treatment plant maintenance
- Daily meter reads move in/outs.
- Locates as requested around town
- Fill pot holes around town.
- Mow grass in parks
- Train employees at both water and wastewater plants
- Clean sewer lift stations
- Various afterhours WTP and WWTP alarms
- Install several street signs around town
- Inspect new Water / Sewer connections.
- Clean treatment plants top to bottom.
- Clean, unplug and TV sewer main around town.
- Install several new water meters at new connections
- Help power crew.
- Water leak detection around town.
- Collect and submit lead and copper tests.
- Update water cross connection program.
- Work on new construction projects and updates.
- Repair chlorine issues at WTP
- Fix several water leaks around town
