JANUARY_2022 REPORT

General

We regretfully announce that Officer Duran will be resigning from the Eatonville Police Department. He has faithfully served our community since August 15th, 2019.

He will be pursuing another calling, outside of law enforcement. Although he has provided notice, he has graciously temporarily postponed his departure to allow us to begin the process of finding his replacement.

Public Safety Committee

The committee discussion centered around the current contract with the Pierce County Sheriff's Department for the Chief of Police.

Management Activities

Eatonville is experiencing a slight decline of incidents of commercial and private theft/burglary cases which are consistent with the surrounding unincorporated Pierce County areas. Catalytic converter thefts have increased, however.

We have selected a vendor for the body camera redaction software that will enable us to remain compliant with WA State RCW and WAC redaction laws. This will be presented to council for approval.

I have been attending weekly updates from Washington Association of Sheriffs and Police Chiefs (WASPC) regarding legislative updates on bills pertaining to police reform. It is encouraging to see there are fixes in the works to allow law enforcement to better protect their citizens and hold criminals accountable. Two of the marquis bills are HB 2037 and SB5919. The legislation is seemingly listening to the advice of law enforcement and victimized citizens of failures of the bills that went into effect in 2021.

In December 2021- EPD had 130 total calls for service.

22 traffic stops – 8 Notices of infraction, 1 citation w/ release misdemeanor

0 misdemeanor arrests (non-traffic) - booked





SOUTH PIERCE FIRE AND RESCUE

- SPFR has begun negotiations with Local-726 to reorganize district command structure
- SPFR is in process to find a new Chief Financial Officer and Board Secretary.
- SPFR has started an addition voluntary firefighter academy in conjunction with Browns Point with four additional recruits. We will be running another in-house academy later this year
- SPFR has completed a traditional "Push In' ceremony for the new E21-1 on February 12th, 2022, that will be housed at Station #170 at 5403 340th E Eatonville, WA
- SPFR has purchased a new set of extrication equipment to update and upgrade the capabilities at Station 84, here in the Town of Eatonville
- The Fire Chief and Board of Commissioners have met with the mayor about the ongoing contract between the Town of Eatonville and SPFR
