A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON, CONFIRMING THE MAYOR'S APPOINTMENT OF JOE HAGEN TO THE POLICE CIVIL SERVICE COMMISSION

WHEREAS, pursuant to Eatonville Municipal Code (EMC) Section 2.34.010, the Town of Eatonville has established a Police Civil Service Commission (the Commission) which is composed of three persons appointed by the Mayor and confirmed by the Town Council; and

WHEREAS, pursuant to EMC 2.34.040, the term of office of the members of the Commission shall be for six years; and

WHEREAS, position #1's current term dates are June 1, 2018 through May 31, 2024 and is vacant; and

WHEREAS, Joe Hagen has completed an application for appointment to fill a vacant Civil Service Commission position; and

WHEREAS, the Town Council wishes to confirm the appointment for position #1 of the Civil Service Commission; now, therefore,

THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

THAT: The Town Council hereby confirms the Mayor's appointment of Joe Hagen to position #1, of the Police Civil Service Commission beginning March 1, 2022 and expiring on May 31, 2024.
