RESOLUTION 2022-FF

A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON, AUTHORIZING THE USE OF CORONAVIRUS RECOVERY FUNDS TO PURCHASE TASERS FOR THE EATONVILLE POLICE DEPARTMENT

WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 ("ARPA") was signed into law, and established the Coronavirus State Fiscal Recovery Fund and Coronavirus Local Fiscal Recovery Funds, which together make up the Coronavirus State and Local Fiscal Recovery Funds ("SLFRF") program; and

WHEREAS, ARPA provides a total of \$350 billion in emergency funding for eligible state, local, territorial and Tribal governments; and

WHEREAS, the Town of Eatonville's total allocation of ARPA funds is \$844,702.00, with 50% provided in June 2021 and the balance expected in June 2022; and

WHEREAS, the current Eatonville Police Department tasers are outdated and in need of replacement; and

WHEREAS, the purchase of new tasers for each officer qualifies as an approved use of ARPA funds; and

WHEREAS, the Public Safety and Finance Committees met and discussed the use of ARPA funds to cover the cost of the tasers and recommends approval of allocating these funds; and

THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

THAT: The Town of Eatonville is authorized to expend \$13,954.27 from the Town's allocation of American Rescue Plan Act funds for the purchase of 5 tasers as outlined in the quote from Axon Enterprises, attached hereto as Exhibit A.
