A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON, AWARDING A BID FOR A TOWNWIDE CRACK SEALING PROJECT

WHEREAS, the Town of Eatonville (Town") has been awarded a grant from the Washington State Transportation Improvement Board ("TIB") for 94.9993 percent of approved eligible project costs up to \$52,166.00 to be used for crack sealing; and

WHEREAS, on June 13, 2022 the Eatonville Town Council approved Resolution 2022-HH accepting the TIB grant; and

WHEREAS, the Town of Eatonville solicited bids for a townwide crack sealing project and the lowest responsible bid was Transblue in the amount of \$54,911.52, the total amount of the bid after tax is \$59,304.45; and

WHEREAS, the financial impact to the Town will be \$7,138.45 after the grant is received; and

WHEREAS, the Finance Committee met and discussed the low bid and recommends approval and is in support of using Transportation Benefit District funds to cover the financial impact to the Town; now, therefore;

THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:

THAT: The Town Council approves, and the Mayor is authorized to execute on behalf of the Town, an agreement in the amount of \$59,304.45 to perform the townwide crack sealing project with Transblue, as outlined in the proposal attached hereto as Exhibit A.
