General

Management Activities

The negotiations to purchase my former patrol car from PCSD is ongoing and is "on the desk" of Pierce County Finance. I should receive a quote soon which I can present to the mayor/council for approval.

I applied for a grant through the Department of Justice to obtain funding for officer body armor for our replacement officer (restrictions of the grant). We should receive confirmation before the years end.

EPD received a partial delivery of our ballistic helmets which were funded by a grant. We are waiting to receive the 2 remaining helmets and the ear protection which are on backorder.

On June 8thth I attended the Eatonville Business Association meeting. I was the guest speaker, and I covered the topic of communications.

On June 22nd, Chief Wernet and I held a "Coffee with the Chiefs" at Bruno's restaurant. We had 7 citizens attend as well as with Pierce County Sheriff's Department Lt. F. Brown and Sgt. E. Clark.

Officer McGuire's vehicle was outfitted with our new graphics and is in service. We will phase the remainder of the cars in over time to keep consistency in our branding.

We opened our officer search to entry level in addition to lateral applicants. We have not received any lateral applicants and only 2 entry levels. I am in the process of researching ways to increase our competitiveness in the law enforcement market and to enhance our retention of our current officers. This includes a proposed wage increase which I presented to the finance committee on June 13th.

On June 30th we received our new Tasers which were purchased with ARPA funds. Lakewood PD will be providing certification training for me and my officers since the new Tasers have several new features and capabilities that were not available on our current Tasers.
