

## **RESOLUTION 2022-XX**

### **A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON UPDATING FEES RELATED TO PAST DUE UTILITY PAYMENTS, DISCONNECT NOTICES, UTILITY RECONNECTION AND REPEALING RESOLUTION 2013-KK**

**WHEREAS**, the fee schedule for certain utility charges was last updated in 2013; and

**WHEREAS**, the administration of placing disconnect doorhangers is burdensome on office staff as well as public works staff; and

**WHEREAS**, the Public Utilities Committee met to discuss the addition of a fee for placing disconnect doorhangers at each physical address and recommends approval of this additional fee, as well as an increase in the reconnection fee; and

**WHEREAS**, the Town Council desires to review and update its schedule of fees and charges from time to time; now, therefore,

### **THE TOWN COUNCIL OF THE TOWN OF EATONVILLE, WASHINGTON, HEREBY RESOLVES AS FOLLOWS:**

**Section 1.** The late fee for utility services not paid within 25 days after the date of billing shall be fifteen dollars (\$15.00).

**Section 2.** The administration fee for placing a disconnect doorhanger at each physical address shall be twenty-five dollars (\$25.00) per doorhanger.

**Section 3.** Reconnection fees for utility services shall be in addition to late payment fees and all other charges, and shall be as follows:

- a. Payment of all past due charges, including reconnect fee, made by 4:00 p.m. on a Town business day for reconnection on the same day..... \$50.00
- b. Payment of all past due charges, including reconnect fee, made after 4:00 p.m. on a Town business day for reconnection on the same day..... \$100.00
- c. Payment of all past due charges, including reconnect fee, made after 4:00 p.m. on a Town business day, or by special arrangement on a non-business day, for reconnection on the next Town business day.....\$50.00
- d. Additional charge for electrical service disconnected at the pole rather than at the meter box..... \$50.00

**Section 4.** The tampering charge for reconnection of utility service by other than Town personnel shall be five hundred dollars (\$500.00).


**Section 5.** Resolution 2013-KK is repealed in its entirety.
