We had great discussions surrounding our topics this evening. We had three public hearings this evening.

- 1. **Title 18: Sign Code**:We voted to send Title 18 to the council.
- 2. **Title 20: Short Term Rental Regulations**: We voted to send Title 20 to the council with one change. That we change the frequency of inspections from one year to three years after hearing public testimony on this topic.
- 3. **Commercial Overlay District**: After hearing public testimony, we decided to table the Commercial Overlay District piece of code to get more input from the town attorney regarding the language "Non-comforming use" and "Legal Non-conforming use." We will be discussing this again and having another public hearing on it in the near future.
