Management Activities

We were awarded a grant to supplement the purchase of a bullet proof vest through the United States Department of Justice / Patrick Leahy Bullet Proof Vest Partnership program in the amount of \$482.07. This can be applied toward the purchase of a new vest carrier and ballistic panels for our new officer.

On August 4th I attended a regional law enforcement breakfast meeting involving surrounding agencies such as the Pierce County Sheriff's Department (PCSD), Yelm PD, Joint Base Lewis McChord Police, and the Thurston County Sheriff's Department. This will be a reoccurring monthly meeting and is an excellent networking opportunity to discuss legal updates, trans-jurisdictional case information, training, and current trends.

The hiring process for our later candidate is underway. They have successfully completed the polygraph, psychological, and medical exams. I anticipate providing the candidate an offer of employment by the beginning of October with a start date of October 15th.

We had great discussions surrounding our topics this evening.

- 1. **Commercial Overlay District**: We received word from the town attorney regarding the concerns the citizens had about the commercial overlay district language and how the existing non conforming use language will appear in the code proposal. He has written his response and recommendations to us. Please see attached below.
- 2. Comprehensive Plan Update Schedule Planning: Mr. Shields gave us a broad overview of how he, the planning commission and future advisory committees will start planning and implementing the two year long process that is the Comprehensive Plan Update. The idea is to be well on our way with the actual work starting early next year. More details to come.

Attorney Recommendations for the Commercial Overlay District:

1: A little background:

At the comments section of the Public Hearing last month, a citizen brought up a good point regarding the language defining the existing residential structures within the proposed overlay district. They were concerned with the term "nonconforming use" and the effect that would have on mortgage companies backing loans on residences within the overlay district if a house was sold or was being remodeled to sell or keep while under the restrictions of the overlay zone. We thought it prudent to go to the town's attorney for an answer to these questions and he got back to us with two separate recommendations.

Referencing 18.8.100, the town's non conforming use ordinance he wrote this below:

E. Vesting

- 1. All residential homes in existence as of the date of the adoption of this overlay shall be considered a legal nonconforming use subject to the provisions of Title 18.8.100 of the Eatonville Municipal Code except:
 - a. A residential home shall forfeit the allowed nonconforming use designation and shall be subject to the applicable restrictions of this provision only if that residential home is intentionally or voluntarily demolished and
 - b. The owner shall be entitled to repair and construct damage caused by a natural disaster regardless of the value of the damages.

Remove the below language:

2. Any residential home that is intentionally and voluntarily demolished forfeits the allowed nonconforming use designation and shall be subject to the applicable restrictions of this provision.

That was one option. The other option is below:

E. Vesting

- 1. All residential homes in existence as of the date of the adoption of this overlay shall be considered a legal nonconforming use subject t the provisions of Title 18.8.100 of the Eatonville Municipal Code except:
 - a. The period of discontinuance that forfeits the nonconforming use designation shall be one year rather than six months; and

- b. The owner shall be entitled to make renovations, additions and other structural alterations consistent with the residential nonconforming use of their property, subject to the approval of the planning director.
- 2. Any residential home that is intentionally and voluntarily demolished forfeits the allowed nonconforming use designation and shall be subject to the applicable restrictions of this provision.

Please inform either myself or the mayor/staff of your preference regarding what direction you would like to take and we will incorporate it into the final draft for your thoughts and approval. Thanks.
