General

Management Activities

I am pleased to announce our newest officer, Jeffrey "JJ" Justman, has complete his field training and is now working on his own.

Officer Justman served as a Sergeant and Officer with the city of Ocean Shores before coming to the Town of Eatonville. However, Officer Justman is no stranger to the area as he was a professional mountain guide for over 20 years based in Ashford, WA. He has climbed the world's highest mountains including Mount Everest and he has 238 summits of Mount Rainier. Officer Justman holds an undergraduate degree in Health Promotion and Wellness and a Masters degree in Interpersonal/Organizational Communication. Officer Justman holds certifications in Crisis and Hostage Negotiations and is also a Public Information Officer. With his background and love of the mountains, Officer Justman is very excited to be serving the Town of Eatonville.

EPD and the employees of the Town of Eatonville sponsored a family for the Secret Santa gift giving organized by Eatonville in Action. A huge thank you to Emmy Lay for allowing us to participate in this gifting opportunity!

We took delivery of our pool car and it meets and exceeds our expectations. I was able to remove the Squaxin Island PD graphics saving the town approximately \$500. The vehicle was fully equipped, to include a speed radar unit. The only pierce of equipment not provided was a police radio (Squaxin Island has incompatible radios) which we will purchase later. We are hopeful to be able to surplus the two radios provided to recover some costs.

I have enrolled all of my officers (and myself) in an online leadership academy, the Credible Leadership Series. This is hosted by the Washington Association of Police Chiefs (WASPC). The academy is 187 hours through 47 different modules and is self-paced. This series is designed to provide a comprehensive introduction to leadership, ethics, character, supervision, communication, and self-development for the Emerging Leaders. Although our department does not currently offer any promotional or "leadership" positions, I recognize that we are all leaders in our community. The lessons learned in this academy can be translated in to strengthening that leadership within the community and in every other aspect of our lives. Additionally, the academy hours can be transferred for college credits. I believe this is a positive step in the further development of my officers. This academy is available at no cost to the Town of Eatonville.

SOUTH PIERCE FIRE & RESCUE

- SPFR continues with mediation, negotiations, and promotional process with Local #726 for a new Firefighters contract, Battalion Chiefs position, and to fill a vacant Lieutenants position.
- SPFR has hired two new paramedics. We would like to welcome Mitch Holbrook & Forrest Hanson to our family. They started on December 1st and will start the WA State Fire Academy on January 25th. We have also offered Volunteer Firefighter Chris Donohue a conditional offer to start on January 1st and join the two new paramedics in the State academy.
- SPFR's in house voluntary firefighter academy is complete and we would like to congratulate the four firefighters from Riverside & SPFR who successfully completed academy 22-1. We also have one firefighter remaining in the Browns Point Fire Academy. They will be doing their final testing December 17th.
- SPFR continues to participate in Pub Ed events including the Eatonville Christmas Parade, and 4 days of Santa Runs. We have and continue to schedule Fire Station Visits by home school Co-ops.

We had great discussions surrounding our topics this evening.

- 1. Comprehensive Plan Update Schedule Planning: The town will be getting a new planner hopefully soon from what we were told so we will have more information on that soon next month after the holidays. Seth Boettcher gave us an overview about our UGA and the related requests coming from the long range planners at Pierce County about reducing it. There were some areas that were highlighted that could be removed from the town's UGA and Mr. Boettcher is in ongoing discussions with Pierce County. This was related to the Comprehensive Plan Update.
- 2. Changes to Overlay District: After discussing the feedback from council, we decided it was best to go with the option that puts existing homes within the proposed overlay under the regulations only if they intentionally demolish the home. See Mr. Boettcher for the language.
- **3.** Commercial Overlay District Public Hearing: We had our public hearing on the overlay zone and voted to send it back to council with the changes made earlier in the evening.

- 1. Shoreline Master Program Update: We got a conditional approval from the Department of Ecology before the previous planner left.
