In the application it asks for my employer I would like to explain why I do not work. My husband and I have two young adult children who rely on my availability for help because they have special needs. This has been the reason I no longer work away from home for now.

Education- Brooks Industry, Cerritos C.C., Cal State Fullerton, Completed Early Education Cert., Ground School at Spanaflight.

On the question for the application process, it was asked to share some experiences or qualifications that relate to the work of this committee.

I was a commercial Credit Manager for 14 years. I handled bankruptcy, attorney and legal transactions, personal guarantee, international banking, letters of credit and liens. It was also my job to review and submit contracts/bids to various accounts, banks and extend credit. In addition, the accounts were military, government, international and regular customers. The books had approximately 4 million with only a .01% loss.

I have volunteered at Graham Kapowsin H.S. developed a program and club with a non-profit account with the PTA. It was called Unify-One for the special education department that integrated kids with the peers at the school. We sold popcorn so that the profits went to special education department. It paid for all the costs transportation, staff, food and activities for monthly field trips. It taught the kids self-courage, social integration, counting and dispensing money, social skills for special needs it was all done with the sale of each bag of popcorn in the school during lunch time. The kids grew socially, learned skills and developed friendships all with serving popcorn. It was a program that I walked away knowing these kids were given opportunities and thrived for the better. This was put on hold do to Covid.

My most recent experience was Volunteering for over 4 years at Spanaflight Aviation, Puyallup. I did various jobs in the office. But most notably I was putting the bid together for the Fuel Island for Thun Field. The process was very detailed and specific with the Pierce County office. I also during this time attended Ground school to better understand Flying, I scored 96%

in class. I did this so I understood Aviation and how it functioned. I put the love of aviation in how I approached new students and enjoy the community that aviation has.

I am a 3rd generation aviation family this is a lifestyle. My father was a pilot my husband is a private pilot and our son a student pilot. I bring drive, commitment to the job, business sense and willingness to work with others. Also bringing the aviation industry further to the Eatonville Airport. My husband and I live on this airport we look at this as a lifestyle and love the community. I look forward to being a contributing and supportive part of this commission.
