MAY 2023 REPORT

General

<u>Public Safety Committee</u> – no meeting in May.

Management Activities

In May, I attended reoccurring monthly meetings such as the Pierce County Chief's Association, Eatonville Steering Committee, Eatonville Business Association, Coffee with the Chiefs, WASPC legislative briefings, the south sound law enforcement breakfast, and the Eatonville School District Safety Committee.

10 of the 11 Flock license plate readers have been installed and are in working order. The remaining camera is pending permitting from the State. The system is already proving to be beneficial and has assisted in 2 investigations and provided 31 "hotlist hits" thus far. The system went online on May 15th. As of June 5th, the system has read 374,162 license plates.

May 2nd through the 6th I attended the Professionalizing Law Enforcement Community Engagement Training national conference in Atlanta, GA. It was the first annual conference and was attended by law enforcement from all over the country. The symposium was split up into breakout sessions and were instructed by respected leaders, represented by law enforcement and non-law enforcement professionals. The sessions focused on how to maximize community interaction and engagement.

On May 17th I helped serve pizza at Myles Pizza Depot for Pizza Wednesday.

On May 18th EPD participated in a fundraiser for the Eatonville Family Agency by selling donuts at the Gypsy Wagon. The proceeds totaled \$430.

SOUTH PIERCE FIRE & RESCUE

- Burn Ban is now in affect in all unincorporated Pierce County as of June 7, 2023. This will remain in effect until further notice.
- SPFR continues mediation with Local #726 for a new Firefighters contract and Tentative agreement for Battalion Chiefs contract.
- SPFR continues negotiations for a Fire and EMS contract with the Town of Eatonville for 2024 and possible annexation for 2025.
- SPFR continues its Volunteer Fire Academy, CVA 23-1 the "Skull Crushers". Members from SPFR, Browns Point, Ashford Elbe, and Riverside will be participating in H.O.T. training over the next few weekends for Forcible Entry, Ventilation, & Live Fire at North Bent Training Center. They will also be taking Haz Mat training later this month.
- SPFR continues to participate in Pub Ed events. Eatonville Homeschool Career Day, Lacamas Fair, Roy Rodeo, Fire Station Open Houses, Rod knockers Car Show,
