**CALL TO ORDER**

Mayor Baublits called the meeting of the Eatonville Town Council to order at 7:00 p.m.

### **RESOLUTION 2023-X**

A Resolution of the Town of Eatonville, Washington, authorizing the Mayor to execute an amendment to the Interagency Agreement with the State of Washington, Department of Ecology.

Town Clerk Miranda Doll read the Resolution by title into the record.

Councilmember McFadden made a motion to approve Resolution 2023-X and was seconded by Councilmember Litzenberger. All were in favor.

### **COUNCIL MEMBER COMMENTS**


