



**EATONVILLE TOWN COUNCIL  
MINUTES OF REGULAR  
COUNCIL MEETING**

**CALL TO ORDER**

Mayor Baublits called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**ROLL CALL**

Town Clerk Miranda Doll called the roll. The following were:

Present: Councilmembers Kyle Litzenberger, Mike Schaub, Bill Dunn and Emily McFadden. Councilmember Dunn made a motion to excuse Councilmember Paul and was seconded by Councilmember McFadden. All were in favor.

Also Present: Mayor Baublits, Town Clerk Miranda Doll, Town Administrator Seth Boettcher, Police Chief Jason LaLiberte and Fire Chief Todd Wernet.

**OPENING CEREMONIES**

Mayor Baublits led the assembly in reciting the Pledge of Allegiance to the American Flag.

**APPROVAL OF AGENDA/SET TIME RESTRICTIONS**

Councilmember Litzenberger moved approval of agenda with a three-minute time limit and was seconded by Councilmember Dunn. All were in favor.

**COMMENTS FROM CITIZENS**

Lorraine Van Eaton Chang, 301 Center St E – spoke regarding the alley between her property and Mill Haus. She would like to go on the record to say she still wants full use of the alley way that remains. She also wanted to report the parking that is happening on Adams Ave. This is a very narrow street without street parking, so it does block the roadway.

Roslyn Henricks, 465 Airport Rd E – gave an update on the bicycle park. She met with Administration and Council, visiting potential sites. She is hoping that it can proceed in a timely manner for the RCO grant. She is also concerned with the timing of the bicycle park in the CIP.

Lorraine Van Eaton Chang asked about the Center St E Sidewalk project. Discussion was held regarding this project.

Roslyn Henricks inquired about the funding for the trail extension and asked if the funding can be shifted to a different project if that one is not a viable option.

Not hearing any additional comments, Mayor Baublits closed the public hearing at 7:27 pm.

## **DISCUSSION – LEVY LID LIFT**

Council and Administration held discussions regarding options for bringing forward a Levy Lid Lift. Staff will prepare something for the next Council meeting and Mayor Baublits will provide additional information.

Councilmember McFadden thanked everyone for coming and asked what the next steps are for the bike park. Does Council need to set some funds aside? She also stated that the 3<sup>rd</sup> and 4<sup>th</sup> festivities were wonderful and there was a great turnout.

Councilmember Dunn discussed the bicycle park and the timeline for the funding to include the use of ARPA funds. He also thanked everyone for coming.

Councilmember Schaub asked for an update on the Aviator Heights bond and thanked everyone for showing up.
