MINUTES OF REGULAR  
COUNCIL MEETING**

**CALL TO ORDER**

Mayor Protem Dunn called the meeting of the Eatonville Town Council to order at 7:00 p.m.

**ROLL CALL**

Town Clerk Miranda Doll called the roll. The following were:

**OPENING CEREMONIES**

Mayor Protem Dunn led the assembly in reciting the Pledge of Allegiance to the American Flag.

**APPROVAL OF AGENDA/SET TIME RESTRICTIONS**

Councilmember Paul moved approval of agenda with a three-minute time limit and was seconded by Councilmember McFadden. All were in favor.

Councilmember Paul made a motion to approve the consent agenda and was seconded by Councilmember Schaub. All were in favor.

**DEPARTMENT HEAD/COUNCIL COMMITTEE/BOARD/COMMISSION REPORT**

- A. **Fire Report** – Fire Chief Wernet reported that he was able to visit Columbia Crest today for 9-11. He has also fulfilled all the requests from Administration for negotiations.



- B. Public Works Report** – Councilmember McFadden inquired about the email update for the Public Utilities Committee. The Town Administrator will add it to his list. Councilmember Dunn asked for clarification on several items in the report included in packets.
- C. Parks & Recreation Committee** – Councilmember McFadden stated that the Committee met on the 7<sup>th</sup> and discussed the purchase of an art piece using funds allocated to the Town by Amy Cruver. The Committee asked Administration for some additional information, and they hope to bring the discussion to full Council.

### COUNCIL MEMBER COMMENTS

Councilmember McFadden stated that she had to work on Saturday and could not attend the 9-11 Day of Service, but she appreciates all who could. She also said she is glad to see there has been some communication between the Town and the Fire Department and hopes to see the contract move forward.

Councilmember Paul reported that the 9-11 Day of Service was exceptional, and he was able to help with several projects. He said that it was actually hard to find trash to pick up.

Councilmember Litzenberger echoed the statements regarding the Day of Service, it was an awesome event. There were projects at multiple locations around Town and the Blood Mobile was also in Town.


