# A) 427 Jet Ct – Variance Review

Town Administrator Boettcher passed out James Bieker's letter requesting that the airport Commission create and recommend language for the municipal code that defines what will be allowed for construction in the case of a variance being issued following an FAA study. Mr. Bieker is asking for the variance on the height and distance proximity to the airport regarding the structure he would like to build. The FAA study disclosed that the structure would have no substantial effect on air navigation.

Tom Cornwell read an email from Mr. Bieker and presented the Commission with a drawing of the plat.

After the Commission reviewed the proposed variance on Tom's future property, they recorded their individual reasons for support of the variance.

## **COMMISSIONER COMMENTS**

Commissioner French read Resolution 2024-01. The Resolution of the Eatonville Airport Commission Affecting Future Construction On or Near Swanson Field.

Commissioner McNary moved to approve Resolution 2024-01; Commissioner Ireland seconded the motion. All were in favor.
