**A RESOLUTION OF THE TOWN OF EATONVILLE, WASHINGTON, AUTHORIZING
THE MAYOR TO EXECUTE A CONTRACT WITH AXON ENTERPRISE, INC FOR
BODY CAMERAS FOR THE EATONVILLE POLICE DEPARTMENT**

WHEREAS, the Town Council approved Resolution 2021-Z on July 26, 2021, authorizing a Service Contract with SecuraMax for the purchase, software service and hosting of bodycams for 5 years; and

WHEREAS, the body cameras under the agreement with SecuraMax were not performing as expected and the Eatonville Police Department wishes to enter into a new agreement for new cameras, software and hosting with Axon Enterprise, Inc; and

WHEREAS, there is no penalty for terminating the SecuraMax agreement and the agreement with Axon Enterprise, Inc is a savings to the Town of Eatonville; now, therefore;
