



**EATONVILLE TOWN COUNCIL
MINUTES OF REGULAR
COUNCIL MEETING**

DATE: May 26, 2026

PLACE: Eatonville Community Center/Virtual Zoom Meeting.

CALL TO ORDER

Mayor McFadden called the meeting of the Eatonville Town Council to order at 7:00 p.m.

ROLL CALL

Town Clerk Miranda Doll called the roll. The following were:

Present: Councilmembers Kyle Litzenberger, Peter Paul, Bill Dunn and Colin Stephens.
Councilmember Paul made a motion to excuse Councilmember Schaub and was seconded by Councilmember Dunn. All were in favor.

Also Present: Mayor Emily McFadden, Town Clerk Miranda Doll and Town Administrator Eric Phillips.

OPENING CEREMONIES

Mayor McFadden led the assembly in reciting the Pledge of Allegiance to the American Flag.

APPROVAL OF AGENDA/SET TIME RESTRICTIONS

Councilmember Dunn moved approval of agenda with a three-minute time limit and was seconded by Councilmember Paul. All were in favor.

Councilmember Paul made a motion to approve the consent agenda and was seconded by Councilmember Litzenberger. All were in favor.

DEPARTMENT HEAD/COUNCIL COMMITTEE/BOARD/COMMISSION REPORT

- A. **Mayor's Report** – Mayor McFadden let the Council know that the hanging baskets were put up last week and the crew spent a lot of time getting the Town looking good before Memorial Day weekend.

ROY COURT PROPOSAL DISCUSSION

Caleb Ortega and Katy Henricksen with the City of Roy gave a presentation on the proposal for Eatonville to move court services to Roy Municipal Court.

Councilmember Dunn made a motion to send the item to the Public Safety Committee for additional review and discussion and was seconded by Councilmember Paul. All were in favor.

RESOLUTION 2026-Y

A Resolution of the Town of Eatonville, Washington, awarding a bid for the 2025 Chip Seal Project to Doolittle Construction.

Town Clerk Miranda Doll read the Resolution by title into the record.

Councilmember Paul made a motion to approve Resolution 2026-Y and was seconded by Councilmember Stephens. All were in favor.

RESOLUTION 2026-Z

A Resolution of the Town of Eatonville, Washington, authorizing the execution of a professional services agreement with Psomas, Inc for construction management services on the 2025/2027 Chip Seal Project.

Town Clerk Miranda Doll read the Resolution by title into the record.

Councilmember Litzenberger made a motion to approve Resolution 2026-Z and was seconded by Councilmember Paul. All were in favor.

COUNCIL MEMBER COMMENTS

Councilmember Litzenberger thanked everyone for showing up and stated that, since the legacy court cases are taken care of with Bonney Lake, a transition to court in Roy shouldn't be too difficult. He also said that the hanging baskets look good.

Councilmember Paul concurred with Councilmember Litzenberger and thanked everyone for coming.

Councilmember Dunn said that he was surprised that there was nothing on the agenda for the Centerpoint developer agreement as there are only 2 meetings before the current agreement expires. He also thanked Miranda for getting the information from when the original one was

approved for him to review. He stated that he would be in favor of possibly extending the current agreement for 6 months so it can be further evaluated.

Councilmember Stephens inquired about whether there had been word back on the Ridge Road repair. Mayor McFadden stated that there had not been and that Nick had proceeded forward with getting bids. He said the hanging baskets look good, but he would like to see the Town staff use more safety precautions when hanging them.

With all business completed, Mayor McFadden adjourned the meeting at 7:55 PM.
