CALL TO ORDER

Mayor McFadden called the meeting of the Eatonville Town Council to order at 7:00 p.m.

ROLL CALL

RESOLUTION 2026-BB

COUNCIL MEMBER COMMENTS

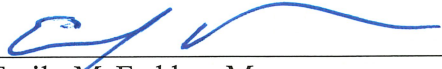
Councilmember Litzenberger thanked everyone for coming. He also explained his concerns regarding Resolution 2026-BB and extending the current development agreement with CenterPoint.

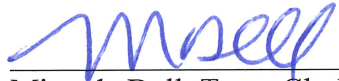
ADJOURNMENT
