





Celebrating 100 Years of Service:

1920 - 2020

In 1920, we were founded as the Anita M. Baldwin Hospital for Babies. Ms. Baldwin founded the Hospital after losing her own twins shortly after birth. She took her tragedy and dedicated herself to supporting the health of mothers and babies, first occupying three beds on the campus of California Hospital. The Hospital continued to grow and by 1945, we opened the first preschool dental clinic in the western U.S. and oversaw 30 inpatient pediatric beds. In later years, our mission expanded from infants and children to community members across the lifespan.

Over the last two decades, Eisner Health has expanded to new locations and enhanced capacity to meet evolving community needs. With a transformative gift from the Eisner Foundation in 2002, our organization was renamed; and two years later we received certification as a Federally Qualified Health Center. In 2020, we celebrate our legacy and reaffirm our promise to improve the physical, social and emotional well-being of everyone we serve.


























Telehealth Emerges to Increase Patient Care Amidst COVID-19

Before the national emergency was declared in March 2020 due to the COVID-19 pandemic, Eisner Health — like all Federally Qualified Health Centers (FQHCs) in California — was only permitted to use telehealth services in very limited circumstances with barriers that prevented any systemic capacity to be implemented. On March 23, 2020 these barriers were lifted, and Eisner Health immediately converted more than 75% of our patient visits to telehealth appointments.

Overnight, we changed the way we are able to care for our community. Patients no longer put off a visit due to travel time, lack of daycare and/or lost wages, but can speak directly to their doctor at their convivence, whether that be at home or on a break at work. The ability for us to provide care in person, on the phone and through video calls is leading to better health outcomes for our patients and their families.


The Importance of Telehealth Services for Community Health Centers



The chart above breaks down the type of visits we had throughout 2020 to showcase the importance of telehealth to our patients. Since we were unable to conduct telehealth appointments before the pandemic, within our electronic medical record system we did not have an option for a provider to indicate a telephone versus video visit. This new reporting feature was fully functional in May 2020.

Our Women's Health Center is the largest facility of its kind in the L.A. area, with the capacity to serve 11,000 women annually. We are also home to one of the few labor and delivery programs using certified nurse-midwives and OB/Gyns in California. We also partner with several clinics throughout L.A. County to accept high risk prenatal patients.



Eisner Health is the L.A. partner of the national Daddy Boot Camp program, providing monthly workshops in English and Spanish that prepare men to navigate their transformation into fathers.



We are the only community health center in L.A. County to provide periodontics, orthodontics, and palate treatment for our patients.





Teenage Mental Health During a Pandemic

Sara faces her anxiety and panic attacks with the help of her Eisner Health therapist.

Sara is 15 years old, and during a telehealth visit with her provider, she shared she felt disconnected from her teachers and peers and was having anxiety and panic attacks. Sara was referred to an Eisner Health therapist who helped her build healthy coping skills and reduce anxiety due to the impact of COVID-19 and social distance learning. As part of frequent telehealth visits, Sara's therapist worked with her and her family, which includes five other school-age children, to create home structures that fostered a positive learning environment for all. Sara completed the year engaged with her teacher and classmates to complete her assignments.





Integrated Telehealth, the New Paradigm

How telehealth gave this mom with diabetes a second chance.

CM is a 42-year-old Hispanic mother of four children with diabetes and hypertension. Her children range in age from 16 years old to 9 months. Her oldest child has special needs and requires around-the-clock care. Her husband works during the day, so she is the sole caretaker. Before telehealth, CM would bring her oldest son and the baby to her doctor's appointments. It was very stressful for her, so she would regularly skip her doctors' appointments or rush through them as she had her children with her. Thus, her diabetes got very out of control. With the convenience of telehealth, CM is able to access her provider from the convenience of her own home while her kids are relaxed and entertained in their living room. She now has time to listen to her provider during visits, and since her telehealth appointments began, she has learned a lot about her diabetes. She has even been able to see an Eisner Health nutritionist via telehealth, and her diabetes is now under better control than it has been in years.



Prenatal Care in the Age of COVID-19

How one older expectant mom found support.

Cándida, a mid-40-year-old patient, was expecting her second child after giving birth 16 years ago. Her first child was delivered via C-section. She was referred to Eisner Health because she wanted a VBAC delivery (vaginal birth after cesarean), a practice Eisner Health specializes in. However, Cándida developed gestational diabetes and was referred to an Eisner Health dietician by her OB/Gyn. Cándida was able to meet with her dietician frequently because telehealth made access easier. Her sugar levels were controlled, and she was able to have a VBAC delivery.
