Speaker Biographies

Amy Hutsell

Director of Special Projects and Partnerships Georgia's Criminal Justice Coordinating Council

Ms. Hutsell and her team have competitively secured over \$28 million in federal and private foundation assistance for the state of Georgia's criminal justice initiatives. She is a sought-after speaker for state and national training events and conferences. She oversees the Georgia Sexual Assault Response Team (SART) Project which provides technical assistance and best practices training to Georgia's 50 judicial circuits and 159 counties. She chairs the State SART Expert Committee, which provides guidance in the development of resources, such as sexual assault guidelines and model protocols. One such resource, The Georgia SART Guide, is used across Georgia by law enforcement, Sexual Assault Nurse Examiners (SANEs), victim advocates, prosecutors, and judges.

Ms. Hutsell also oversees the state Sexual Assault Kit project which has successfully addressed the state's sexual assault kit backlog and developed a statewide sexual assault kit (SAK) tracking system. She also established and oversees the Georgia Sexual Assault Kit Initiative (SAKI) Task Force which has provided answers to victims and families of cold case sexual assaults and sexually motivated homicides. In that capacity, she worked with the FBI, Texas Rangers, and local law enforcement in identifying Georgia cases associated with Samuel Little, identified as the country's most prolific serial killer.

Along with developing and overseeing the Georgia Coalition to Combat Human Trafficking and Agricultural Labor Trafficking Task Force, Ms. Hutsell is also responsible for the management of all state and federal grants providing direct service funding to sexual assault, child abuse, and human trafficking victim-serving agencies in Georgia.

Ms. Hutsell has over 18 years of experience in sexual assault and child sexual abuse services. She was the Assistant Director of the Gwinnett Sexual Assault Center and Children's Advocacy Center. She is a Board Member of End Violence Against Women International, a member of the Macon Girls' Coordinating Council and was previously a Court Appointed Special Advocate. She holds a certificate in Genetic Genealogy from the University of New Haven's Henry C. Lee College of Criminal Justice and Forensic Science.

Jessica Lamb, the Founder of ARI (arionline.org), has established a national network of tattoo artists and removal specialists dedicated to serving survivors of commercial exploitation, former gang members, and individuals overcoming self-harm and addiction. Drawing from her lived experience as a survivor of child exploitation and independently in the adult entertainment industry, Jessica provides training in Iconography and the history of tattoos. With over 15 years around the tattoo industry and 11 years as an anti-trafficking advocate, she specializes in tattoo identification and iconography. Jessica has trained over 10,000 law enforcement officials, prosecutors, schools/universities, medical professionals, and advocates nationwide and has been a keynote at various galas and events nationwide. Jessica's trainings have packed out rooms at signature events such as Dallas Crimes Against Children Conference, Women Making Their Mark, NCPTF in Arkansas, and other signature conferences and events. She serves as a Iconographer at Skullgames.io and works closely with Law Enforcement agencies to help identify victims and traffickers.

Jessica's impactful work has earned recognition, including being awarded Atlanta Non-Profit of the Year in 2019 and 2020, named in Georgia Trends' 40 under 40 in 2021, and honored as Atlanta Business Chronicle's Social Entrepreneur in Social Empowerment, Top 40 Georgia Innovators in 2022, and featured in 2023's Georgia Women Making Their Mark. Jessica's influence extends nationwide in both the anti-trafficking and tattoo industries. Beyond her role at ARI, she serves as an Art Therapist at Behavioral Health Centers and local safe homes.

Sherri A. Stephan is an Assistant United States Attorney (AUSA) and Human Trafficking Coordinator for the Southern District of Georgia (SDGA), United States Attorney's Office. Sherri has been a prosecutor for 28 years, 22 of those as a federal prosecutor, where she has almost exclusively prosecuted offenders for human trafficking, child exploitation, and organized gang crimes. Prior to joining the SDGA, Sherri spent over 16 years as an AUSA in the Eastern District of Pennsylvania, and five years as a Trial Attorney and then Deputy Chief of the Child Exploitation Section for the United States Department of Justice (USDOJ) in Washington, D.C. She has successfully prosecuted human trafficking conspiracies and used the federal racketeering statutes (RICO) to target human trafficking offenders. Sherri was recently awarded the 2024 - Prosecutor of the Year Award from Homeland Security Investigations – Philadelphia and received the 2023 - USDOJ's Director's Award for Superior Performance as an Assistant United States Attorney.
