The cost of **OUTFITTER** services and dates of service are listed on the attached **INVOICE**. Final balance on hunt is due July 1. **NO PERSONAL CHECKS** are accepted for final payment in camp. There are no refunds on cancellations or early termination of hunts for any reason unless you or outfitter replaces opening with hunter in possession of current legal tags. Trip Cancellation Insurance is readily available and affordable. We recommend it. Hunt /tour ends on listed date or when game is taken.
2. **CLIENT** is responsible for possessing and purchasing their own hunting and fishing licenses and tags, gun, ammunition, personal clothing, and transportation to and from beginning point of hunt.
3. **OUTFITTER** will assist with licensing procedures, provide meals, accommodations, reasonable transportation from beginning point of tour, hunt, expedition, or adventure, as well as to and from hunting areas, and will clean and package birds. In some cases, accommodations and meals may be in motels and restaurants. **OUTFITTER** will provide adequate guides.
4. **Client** is responsible for all expenses for shipment of birds, taxidermy, commercial and charter flights, and rental vehicles.
5. **OUTFITTER** will provide adequate hunting guides and equipment. There are **NO GUARANTEES**, either expressed or implied, as to the size, color, or quality of the game hunted, or that **CLIENT** will kill or take any game.
6. **CLIENT** may, depending on availability, have with him during the hunt a non-hunting person. Observer rate is \$225 day.
