- **Cleaning Fee:** \$150
- **Security Deposit:** \$750 (due at contract signing to reserve your date; refundable after the event if no damages occur)
- **3.5% Credit Card Processing Fee:** Licensee will be charged a 3.5% service charge (which may be deducted from the deposit or separately billed if the deposit is not sufficient) for all licensee or guest credit card purchases from the bar

## Add-Ons:

- **Dock & Pavilion Access (with building rental):** \$150
- **Furniture Removal & Replacement (pavilion or balcony):** \$150
- **Flatware & Dish Rentals:** Available for an additional fee

## Bar Services

We offer flexible bar options to suit your needs—whether you'd like an open bar, cash bar, bar based on consumption, or a ticketed system.

All packages include appropriate bar glassware at no extra charge.

**Note:** Outside alcohol is strictly prohibited per our liquor license.  
Violations will result in the loss of your security deposit.

## Bartenders (required):

- \$50 per hour, per bartender
- Two bartenders required for groups of 65+ guests

## **Cash Bar Pricing**

- Soda: \$4
- Domestic Beer: \$6
- House Wine: \$9 | Premium Wine: \$13
- House Liquor: \$10 | Premium Liquor: \$13

## **Bar Packages (Per Person)**

- Champagne Toast: \$10
- Soda Only: \$8
- Beer, Wine, Soda: \$50
- Beer, Wine, Soda & Spirits: \$60
- Premium Wine, Spirits, Beer, Soda: \$80

## **Insurance & Coordination Requirements**

### **Event Insurance:**

We require a \$2 million event insurance policy. This typically costs around \$150, depending on the provider. You may use any vendor you prefer; for convenience, many of our clients have used [www.eventhelper.com](http://www.eventhelper.com).

*Additional insurance is required if renting the Pavilion.*

### **Day-of Coordinator:**

A coordinator is required to manage vendor timing and communication with our Club Manager. They must be present from setup to breakdown and attend a walkthrough at least two weeks prior to the event.

*Don't have one? We can provide a coordinator for an additional fee*

## **Catering Details**

We do not require a preferred caterer—you're welcome to bring your own or even cater the event yourself!

### **Caterers must:**

- Provide a Certificate of Insurance
- Clean the kitchen after use
- Take out the trash

If no caterer is used, your day-of coordinator will be responsible for trash removal.

### **Self-Catering Guidelines:**

If you choose to cater the event yourself, please note that use of the kitchen's cooking appliances (e.g., ovens, stove, fryers) is not permitted. However, you are welcome to use the prep space and the provided food warmer for keeping items at serving temperature.

### **Holiday Decor Notice:**

We decorate for Christmas the week before Thanksgiving each year. These decorations must remain in place during events held throughout the holiday season.
