BASED ON the Stipulation of the parties and good cause appearing:

IT IS HEREBY ORDERED as follows:

- 1. The samples listed in the State's Motion for Consumptive Testing may be consumed by the State Lab to determine if sufficient DNA is present to create a DNA profile.
- 2. In the event sufficient DNA is available to create more than one profile, the DNA sample will be split between the parties for testing, and each party may have the expert of their choice test their respective portions of the DNA.
- 3. In the event sufficient DNA is available for only one profile to be created, it is ordered that the State Lab shall halt any further testing and the parties will reconvene at that time to determine who should conduct any further testing.
- 4. In the event the State Lab determines there is not sufficient DNA to create a DNA profile, the parties shall reconvene to determine what, if any, course of action to take regarding the samples.
