**ORDER AUTHORIZING DISCLOSURE
of SEALED INFORMATION**

In response to the issue raised by the State requesting a finding of a conflict of interest in attorney Mark Means' continued representation of the Defendant, the Court has issued a decision and order, contemporaneous with this Order. In making its ruling, the Court has determined that portions of previously sealed documents are required to be unsealed as particular facts from those documents are incorporated into the decision on the State's motion, which decision is not sealed.


Good cause appearing therefore, the Court finds it necessary for the Court, on its own motion, to unseal portions of certain documents in Fremont County Case CR22-20-0755, as well as Fremont County Case CR22-20-0838. Further, the Court finds it necessary to unseal portions of the State's July 27, 2021 motion filed in this case titled "Motion and Memorandum Objecting To Counsel's Entry of Appearance and For a Finding of Conflict" to accompany the decision and order filed contemporaneously herewith.

After due consideration of the factors set forth in I.C.A.R. 32, the Court finds, at this time, a public interest prevails over a prior order preventing the dissemination of such information. Additionally, the Court finds that no reasonable alternative exists to promote a fair and orderly judicial proceeding other than to permit the disclosure and dissemination of information as set

forth in the decision and order issued in response to the State's motion. Therefore, the dissemination and disclosures of information as contained in the decision and order issued as of today's date, are unsealed, limited to only that information contained in the Court's decision and order.

IT IS SO ORDERED.
