1. Interfere with enforcement proceedings;

Wherefore, the State respectfully prays that the Court seal from public disclosure the Stipulation to Extend Return of Evidentiary Items herein under the provisions of Idaho Court Administrative Rule 32(g)(1) and Idaho Code 74-124.
