A MESSAGE From Our Chair and Chief Executive Officer and President HEROES AMONG US







A year ago, the world changed.

There is no dispute that shortly after we began hearing of COVID-19, it quickly and dramatically impacted the Los Angeles Jewish Home. During the initial weeks, there was little known about this mysterious new disease. Facts were few, and the path forward for the country and the world was uncertain.

Here at the Home, together with our outstanding medical leadership, we took quick and decisive action to protect the health and safety of the seniors in our care, as well as our dedicated staff.

Social distancing requirements meant ceasing community excursions, group activities, and even cherished family visits. While much of the world hunkered down, our staff pushed aside any uncertainty they may have been feeling about their own health and safety and reported to work each day. They not only continued providing compassionate care, they also found creative ways to keep seniors safe, healthy, and engaged, while calmly assuring them things would be alright.

In other words, everyone at the Home kept doing what we always do, thoughtfully carrying out our mission, regardless of any challenges we may face, always putting resident care at the center. While we rightly hear a great

deal about the amazing nurses, physicians, and caregivers, *each* person at the Jewish Home earned the badge of "hero" this past year. Our transportation teams; dietary staff; housekeeping staff; those working in laundry services; our maintenance staff; security personnel; activities staff; social services professionals; therapeutic services staff – the list of departments goes on and on, and heroes were actively among us each day.

This annual report puts a spotlight on just a few of the unsung heroes at the Home, those whose efforts made sure the quality of our care never wavered and that care was on full display. Therefore, while typically an annual report covers a fiscal calendar (and our financial reporting does here as well), we have taken the liberty of expanding the timeframe of this report. This was not a typical year. The events we want to share with you did not have a firm start date, and the extraordinary story continues.

We would be remiss if we did not extend immense gratitude to those who made our care possible through their generous financial support. Families of residents, corporations, foundations, individuals, and even representatives of the entertainment industry stepped up to support our COVID-19 relief efforts. To all of you, we say thank you.

In addition, let us not forget our residents, as well as the senior members of the community we care for each day. We have been struck by their strength, patience, and perseverance as they endured separation from their fellow residents and other loved ones for far too long. Each has demonstrated endless grace and dignity in the face of adversity.

Finally, when the vaccines became available, we moved aggressively to secure them for our residents, participants, staff, and others directly connected with the work of the Home. As a result, we were among the first senior care facilities to reach 99% resident vaccination rates.

Thankfully, routines are starting to return, but we will never forget the extraordinary efforts of everyone at the Los Angeles Jewish Home who continued to presevere throughout these unprecedented circumstances. Their efforts demonstrated, perhaps like never before, what distinguishes the Home from all others.

Fully Vaccinated Los Angeles Jewish Home Residents See Hope on the Horizon

Across the country, people are receiving the COVID-19 vaccine, hoping it brings with it the beginning of a return to normalcy. Residents of the Los Angeles Jewish Home are optimistic, buoyed by having received both doses of the Moderna vaccine. All are eager to resume activities that bring them into closer contact once again with their families, loved ones, and friends at the Home.

"Ninety-nine percent of our residents, and approximately 80 percent of our staff, have now been vaccinated," says Noah Marco, MD, chief medical officer of the Jewish Home. "We did it efficiently and safely, which is a hallmark of how we operate here at the Jewish Home."

The speed with which the Jewish Home secured sufficient quantities of the vaccine is testament to the organization's skill, experience, and track record of success, Dr. Marco says. "We were very confident, based on our pre-planning and our relationships with the state and the county, that we would have enough vaccines for everyone. It took the average person at the Jewish Home less than 15 minutes from the time they showed up to receive the second dose, whereas many people across the city and around the country have needed to give up several hours of their day, if they can even obtain a vaccine in the first place."

Of course, even with the vaccine, the Jewish Home is treading carefully and thoughtfully, following all health and safety guidelines to ensure resident and staff wellbeing, as the pandemic stretches into its second year. But, many residents say, inoculation has definitely helped lift their spirits.

"I feel like there is a light at the end of the dark tunnel," says Elaine Cohen, a resident of Joyce Eisenberg-Keefer (JEK) Medical Center on the Jewish Home's Grancell Village campus. "I will someday be able to reunite with family."

Elaine's fellow JEK residents share her positive outlook. "I have a sense of relief and feel honored to have received the vaccine," says Indrani Mahaindra. "This is the beginning of the end of this horrible pandemic." Hersz Alterman notes how thankful he is that a vaccine was developed in such a record-breaking amount of time.

"I'm grateful and appreciate science for creating the vaccine," he says. "Thanks to these incredible researchers, I will someday be able to hug my only granddaughter."

On the Eisenberg Village (EV) campus, residents are also starting to breathe a sigh of relief. "Our last two Town Hall call-in meetings with Jewish Home staff have been even more upbeat and positive, giving everyone a glimmer of hope," says Judith Karon, president of the EV Resident Council. "Residents are thrilled to see things beginning to reopen, like physical therapy and the campus beauty salon."

Sandy Fine, who has taken on a leadership role with EV's resident-run post office, says the response to the planned reopening has been phenomenal. "People really want to be part of it," she says.

Those people include residents Howard Krupnick and Norma Garber. Howard, a new post office volunteer, says he is "happy to have a job and to be helping out at the Jewish Home." As for Norma, she is delighted about finally being able to return to the arts & crafts room. "I was so ready for it," she says. "This is my happy place!"

A HERO IN SUPPORTING THE JEWISH HOME'S COVID-19 RELIEF FUND

The Jewish Community Foundation of Los Angeles (The Foundation) and the Los Angeles Jewish Home have a long history of cooperation in addressing elder care. The Home has received vital Foundation funding over the years for numerous programs and capital projects, and this partnership greatly benefits the growing senior population of Los Angeles. The Foundation is the largest manager of charitable assets and a leader in planned giving solutions for Greater Los Angeles Jewish philanthropists.

In March, as part of their COVID-19 relief efforts, The Foundation generously awarded \$1.3 million to five local organizations to address urgent healthcare needs in the community brought on by the pandemic. The Los Angeles Jewish Home was honored to be one of the five. The Jewish Community Foundation's grant to the Jewish Home was in support of The Brandman Centers for Senior Care—Program of All-inclusive Care for the Elderly (PACE), as well as COVID-19-related expenses incurred in the Max Factor Family Foundation Nursing Building.

The Brandman Centers at LA Jewish Home provides a complete range of health, social, and nutritional services for nursing home-eligible seniors. This grant enabled staff to take resources to the homes of PACE seniors —more than 250 are enrolled— many of whom, due to COVID, were unable to come into the facility for services.

Through their ongoing outreach with local nonprofits and other funders, The Foundation zeroed in on helping the elderly, small businesses, and minority communities to ensure they were receiving everything they needed during the pandemic. President and CEO Marvin I. Schotland shared his thoughts that the pandemic resulted in greater isolation of many seniors who lacked the technology or

knowledge to access essential care. Support of the Jewish Home at this time addresses these critical issues.

"This a global health crisis of a magnitude never experienced in our lifetimes. Vast needs continue to emerge that require support," Schotland, said. "Because The Foundation is in regular contact with non-profits including the Jewish Home, we are able to respond quickly as critical needs are identified, including funding for urgent physical and mental healthcare disparities and businesses that are struggling. With these significant grants to five organizations, our dollars will favorably impact thousands of individuals in need in the Jewish and larger community."



LEADING THE WAY AT THE LOS ANGELES JEWISH HOME

Even in the midst of providing care throughout an unprecedented pandemic, our medical leadership here at the Los Angeles Jewish Home continued to pursue and achieve excellence, making important contributions that called on their experience and expertise. LeadingAge, a national organization representing more than 5,000 nonprofit service providers in the field of aging, asked Noah Marco, MD, the Home's chief medical officer, to serve as a founding member of its new Clinical Advisory Group. The group plays an important role offering guidance on a broad range of issues to the Centers for Disease Control (CDC), the Centers for Medicare and Medicaid Services (CMS), and other influential policymakers. Dr. Marco and his colleagues provided key recommendations to the CDC around vaccine access and distribution in senior communities.

Dr. Marco also shared his knowledge as he participated on a panel on healthcare trends in the senior care industry at "Inspire," MatrixCare's virtual national conference (MatrixCare provides post-acute electronic health records to thousands of facilities and organizations across the country). The gathering brought together a broad range of post-acute care providers to foster dialogue, collaboration, and innovation. In Dr. Marco's panel, titled "New and Emerging Technologies to Support Preventative Care," he spoke about emerging technology trends and how the Jewish Home is using technology to support caring for its patients and residents. One of the many examples Dr. Marco discussed was the integration of a new electronic health record at the Jewish Home's Levy-Kime Geriatric Community Clinic. This undertaking is maximizing the quality of care the Home provides by giving care professionals state-of-the-art tools to help them monitor the heath of participating seniors in our community.



Donor Profile Michael and Zane Koss

Michael and Zane Koss are linked together by more than just DNA. The dynamic father-son duo are both successful entrepreneurs and real estate professionals. Dedicated family men, they each have three children (two daughters and a son) and are married to highly accomplished wives. Also, as passionate advocates for the Los Angeles Jewish Home and other vital causes, each feels a responsibility to help strengthen and sustain their community.

As a father, Michael led by example. His passionate commitment to Jewish continuity, and his focus on providing necessary services to people in need, have touched nearly every aspect of American Jewish life. He is a former chair of the Jewish Federation of Greater Los Angeles, past chair of the American Israel Public Affairs Committee (AIPAC) Western Region, and he recently completed a five-year term on the Board of Regents of Brandeis University. Yet, he says, among the many organizations he has supported, the Jewish Home stands out.

"I believe it's vital we take care of Jewish people throughout their lifetime, and the Home does such meaningful work that makes a difference every day," Michael says.

Michael's son Zane's introduction to the Jewish Home came early. "When I was around 19, my dad took me to an event for The Guardians, one of the Home's volunteer support groups. There were probably about 800-1,000 people there. It was very impactful to see so many people like me, caring about a community and wanting to give back," he says. "I've been a Guardian ever since."

As he grew into adulthood, Zane continued to find inspiration at the Jewish Home. "About 15 years ago, my grandmother was ailing and needed a place to live. She moved into the Home, and I would visit her frequently. The level of care I witnessed was just incredible, and I felt so comfortable knowing she was in good hands," he says.

At about the same time, Zane met his future wife, Elisa. As it turned out, her grandmother was also at the Jewish Home – on the floor directly above his grandmother's room. "When we started dating, we would often go visit the Home together. I guess you could say the Jewish Home was a central part of our relationship!" he laughs.

Today, Zane is co-president (alongside Peter Steigleder) of The Guardians, and Elisa is a past chair of the Women's Division. "The Guardians is extremely special. We all look out for one another and love each other like family," Zane says.

Michael sees a focus on care and comfort as being at the heart of life at the Jewish Home. "The staff are so warm, friendly, and hard-working," he says. "They give residents the kind of personal attention that really enables them to enjoy their days and make the most of this time in their lives."

With more people living longer, thanks to ongoing medical breakthroughs, Michael notes that the Home's expertise in maximizing seniors' health and fulfillment is increasingly important. "My father is 99; his brother just passed away at 94. Hopefully we'll all have the good fortune to reach those ages – and when we do, we'll want to know the Jewish Home is there for us," he says.

In Zane's view, that is precisely why donating to the Home is so essential. "The Guardians and other support groups try to do as much as they can to provide robust financial backing," he says, "but it will take help from the entire community to make sure the Jewish Home is available as a resource for everyone who needs it."

Planned Giving Profile Doctor Returns to His Roots

Jeffrey Lauber, MD, remembers growing up three blocks from the Los Angeles Jewish Home's Grancell Village. As a child, he would ride his bike past the campus as he explored the neighborhood. Today Jeffrey is a resident of Newport Beach, and driving through Reseda all these decades later, everything looks much smaller than he remembers. But the Jewish Home is one thing that has always stayed in his memory. He has been a generous donor for many years, which he attributes to a sense of common roots. "I'm Jewish, and I'm from Reseda, and so is the Jewish Home. And that's good enough for me!" he says.

As a physician, Jeffrey takes the Hippocratic Oath very seriously. "Everyone knows the part about healing the sick," Jeffrey says. "But the oath also talks about comforting the dying and those at the end of their life. People forget about that part. And the Jewish Home does that so well."

Jeffrey is also a big believer in hospice care. During his residency at Tulane University, he spent a year caring for patients near the end of their lives. He wanted to provide dignity and respect to those patients, just as he sees the Jewish Home doing it for residents today.

Jeffrey says the Jewish Home's impressive statistics – average age of residents, 90; average length of stay, approximately three times longer than at most other facilities – are a testament to the organization's incredible expertise. He notes that the Jewish Home provides better care, more nursing hours, and a greater number of social workers than the state's minimum requirements. He also points to the many enjoyable activities at the Home, which give residents something to look forward to every day.

When it came time to plan his legacy, Jeffrey knew the Jewish Home was an organization he wanted to support. He recently included the Home as a beneficiary of his IRA, confident the Home would put the funds to good use. Another factor in his decision was knowing the Home will not be taxed on his contribution, whereas individual beneficiaries would potentially face significant tax implications.



The Guardians

Protectors and Champions of the Jewish Home

Faced with changes to our normal life beyond what we could ever have imagined, The Guardians has continued to persevere. The Guardians was fortunate enough to hold an in-person event right before the pandemic lockdown - its annual "Real Estate Dinner" - on March 5th, 2020. There, the group honored Morton La Kretz, real estate developer and founder of Crossroads Management. More than 500 people were in attendance, and together they raised over \$475,000 for the Los Angeles Jewish Home. Since then, much has changed, but even with restrictions, members have continued to join together virtually to support and connect with one another and to contribute generously. Their creative fundraising efforts and virtual events have been incredibly successful and have included wine and scotch tastings, a virtual poker tournament, and virtual Shabbat events. With the leadership of Co-Presidents Zane Koss and Peter Steigleder and their board, The Guardians launched a GoFundMe campaign. Through a generous \$100,000 matching gift offered by Hal Foonberg, they were able to raise more than \$200,000, as well as an additional \$250,000 toward the Jewish Home's COVID-19 Emergency Relief Fund.

Founded in 1938, The Guardians has been the Jewish Home's stalwart philanthropic partner for more than 82 years. With over 500 members, the group is comprised of men and women of all ages who are committed to ensuring excellent care for all seniors. Membership includes general members (those who are over 40), the

KEY ACCOMPLISHMENTS of the Jewish Home

The Jewish Home provides exemplary service to our community's growing senior population, always staying firmly focused on our mission. Throughout COVID-19, our goals never wavered from delivering excellent quality and compassionate care reflective of Jewish values. While the primary focus of our collective efforts this past year centered around keeping our residents, program participants, and staff safe and healthy, we are also proud of the many other accomplishments that should be celebrated including:

- Brandman Health Plan launched January 1, 2021.
 This Medicare Advantage Chronic Condition Special Needs Plan offers benefits to anyone in Los Angeles County who is Medicare-eligible and has at least one of the following chronic conditions: diabetes, chronic heart failure, cardiovascular disorders or dementia.
- More than 3,000 volunteers wrote notes and shared artwork with residents, sewed masks and gowns, participated in Zoom calls, created gifts for residents, and participated as pen pals.
- The Jewish Home was selected by the Los Angeles Mayor's office to develop a program to test for COVID-19 asymptomatic residents and staff. This program, developed by the Jewish Home, led to an LA Countywide initiative that, by June 30, 2020 had tested 60,000 individuals.
- October marked the successful transition of leadership from Molly Forrest, who steadfastly led the Home for more than two decades, to Dale Surowitz, who after 20 years of volunteer leadership joined the Home as chief executive officer and president. Molly assumed the role of president of the Jewish Home Foundation.
- The Home started administering vaccines to staff and residents December 30, 2020. As of March, more than 4,000 vaccines were given.
- Jewish Home staff administered more than 50,000 COVID- 19 tests to staff and residents.
- The Home raised over \$13.3 million in unrestricted donations, as well as \$3.9 million in restricted donations.
- Brandman Centers for Senior Care (BCSC), a Program of All-inclusive Care for the Elderly (PACE), expanded services to 15 additional zip codes in the East San Fernando Valley of Los Angeles.
- Membership in the Legacy Society, the Home's planned giving support group, grew by 15%.
- More than 2,500 people participated in virtual special events and programs sponsored by The Associates, Executives, and Guardians support groups.
