### **Module 1: The Need for Agile Government**

This foundational week explores why Agile leadership is not just beneficial but essential in modern government settings. Participants will examine the history of events leading up to the unique challenges government leaders face today—rapid policy shifts, public scrutiny, legacy systems, the pressure for transparency and accountability, and more—and how traditional hierarchical structures and leadership strategies often fall short in addressing these complexities and navigating the constancy of change.

### **Module 2: Developing An Agile Mindset & Motivation**

This week focuses on cultivating the values, beliefs, and behaviors that underpin effective Agile leadership in the public sector. Participants will explore what it truly means to "be" Agile, not just "do" Agile, and how mindset shifts can enable adaptability, innovation, and responsiveness within bureaucratic environments.

### **Module 3: The Integrated Agile Framework & Principles for Transformation**

This week details all ten principles of the holistic Agile Framework that was introduced in Module 1. This framework was tailor-made for the complexities of government work. We will explore how to align purpose, people, processes, and the Platform to enable meaningful, sustainable values to those you serve.

### **Module 4: Agile Implementation: Tools, Practices, Catalysts & Force Multipliers**

This week dives deeper into the practice of agile government, learning from case study examples from which participants gain insights about the tools and techniques used to lead Agile initiatives in government settings. Emphasis will be placed on actionable methods, collaborative practices, and implementation strategies that have been adapted to the unique realities of public service. Participants will explore what makes Agile work—and what causes it to fail—in complex, multi-layered organizations, like government business.

### **Module 5: Increasing Trust in Government Through Agile Leadership**

Trust is the cornerstone of effective governance—and one of the most critical outcomes Agile Leadership can help foster. This week focuses on how Agile practices and leadership behaviors can rebuild public confidence, strengthen internal team cohesion, and enhance transparency, responsiveness, and accountability in government services.

### **Module 6: Reflection, Wrap Up & Action Steps for Agile Government**

In this closing module, participants will synthesize key learnings from the program, reflect on personal and organizational growth, and chart practical next steps for leading Agile transformation in their agencies. This week is about turning insight into impact—equipping participants to return to their roles with clarity, confidence, and a concrete action plan.
