RESEARCH

States' Adaptations to Business Compliance Processes in Response to the Pandemic

This research is supported by a grant from the <u>PEW Charitable Trusts</u>. It documents and evaluates state regulatory compliance process changes during the COVID-19 public health emergency and beyond. The final report, which will be released in December 2022, will dive deeply into the adaptations of 10 states and issue recommendations for states moving forward.

2022 Academy Fall Meeting

Save the date for this year's Academy Fall Meeting—a hybrid event with three host sites from Wednesday, November 2, through Friday, November 4. The CIP will host a session on Workforce Data with <u>Results for America</u>, Neurodiversity and Disability in the

Workforce with <u>MITRE</u>, and on how Academy studies help localities provide meaningful work with the <u>National Association of Counties</u> (NACo).







Oversight Working Group and Community of Practice - Session 2

In collaboration with the <u>Carl</u> <u>Levin Center for Oversight and</u> <u>Democracy</u>, this working group focuses on oversight in an intergovernmental context. It provides opportunities for networking, discussing hotbutton topics, and sharing best practices. The second session, currently scheduled for December 2022, will focus on oversight and grants.

Modern Social Services Delivery -Session 3

The third session in this series, currently scheduled for November, will focus on pathways to achieve the modernization of social services. Sponsored by the **Center for** Accountability, Modernization, and Innovation (CAMI), the series focuses on social service programs that are designed and supported by the federal government and implemented at the state and local level. The Center will produce a white paper after this series and hopes to brief federal officials on its findings and recommendations.

Disaster Resiliency and Sustainability

The CIP plans to explore the intergovernmental aspects of disaster resiliency and sustainability. Federal agencies help state and local governments respond to disasters in many circumstances, but localities on the front lines often face significant capacity and resource limitations. This series will focus on tactics for closing the gap between federal agencies' support and the needs of states and localities to prepare for a crisis.

Fostering Effective Intergovernmental



Oversight Working Group and Community of

Partnerships to Maximize Outcomes

Director Augustine moderated a session, Fostering Effective Intergovernmental Partnerships, at the 2022 NACo Annual Conference & Exposition on July 23, 2022. Panelists explained how counties are leveraging partnerships across jurisdictional lines and levels of government to maximize the impact of ARPA (American Rescue Plan Act) funding. Results for America presented a framework for fostering effective intergovernmental partnerships with key examples of those partnerships at work.

Modern Social Services Delivery - Session 2

The CIP held its second in a planned series of meetings to discuss modernizing social services. The September 2022 meeting considered whether pandemic-era flexibilities advanced this objective and identified lessons learned. Sponsored by the Center for Accountability,

Modernization, and Innovation (CAMI), the series focuses on social service programs designed and at least partially funded at the federal level and implemented at the state and local level. The third session, tentatively scheduled for mid-November, will focus on practices needed to achieve modernization.

Practice - Introductory Session

The CIP partnered with the <u>Carl Levin</u>
<u>Center for Oversight and Democracy</u> on
the first of a series on the
intergovernmental aspects of oversight.
The initial meeting in August 2022 laid
the groundwork for developing a working
group comprising local, state, and federal
oversight officials. Future meetings will
provide opportunities for networking,
discussing hot-button topics, and sharing
best practices. The working group plans to
meet again in December.



Claiming Complexity: Solutions to Improve Take-up and Administration of the Child Tax Credit and Earned Income Tax Credit

The CIP partnered with the <u>Bipartisan Policy Center</u> (BPC) to host a conversation with policy experts and stakeholders, highlighting issues with the Child Tax Credit and the Earned Income Tax Credit. The September 2022 event introduced a new BPC white paper discussing bipartisan, intergovernmental solutions that could improve their administration for American families and workers. Topics included Internal Revenue Service modernization, fraud prevention, outreach to underserved communities, and resources needed to streamline enrollment and better customer service.

Demystifying the Public Procurement Supply Chain

The CIP co-sponsored the webinar. Demystifying the Public Procurement Supply Chain – Lessons from the Pandemic & Improvements for the Future with the California Association of Public Procurement Professionals (CAPPO). The October 2022 webinar featured several local leaders who discussed their challenges purchasing needed equipment and supplies during the pandemic. The panel-moderated by Academy Fellow, Stephen A. Hamill (Exchange Administrator, Public Purchasing Exchange) -- agreed that enhanced intergovernmental collaboration and coordination is critical to improving the public procurement supply chain in the midst of COVID-19.

Academy Fellow and Professor Emeritus David Ammons (University of North Carolina School of Government) presented **Local Government Best Practices** Benchmarking. During the CIP cosponsored webinar with Mid-Atlantic StatNet in October 2022, Professor Ammons discussed how his university helped local governments in his region find and learn about top performers' best practices. Following Ammons' presentation, expert panelists discussed ways that the federal government, states, and local colleges and universities could help governments learn from each other and improve public services in the midst of viruses, extreme weather events, wildfires, public safety emergencies, and other crises.
