Why Adaptation?



Extreme weather is hitting harder and more often. Across the United States and the world, storms, floods, wildfires, and heat waves are becoming more frequent, widespread, and destructive.



The cost of disasters is skyrocketing. In just a decade, the billion-dollar disasters in the US nearly doubled from 14 in 2014 to 27 in 2024, putting enormous strain on communities and budgets.



Insurance losses are breaking records year after year. For six straight years, global insured losses from natural disasters have topped \$100 billion.



Smart investments save lives and money. For every \$1 spent on preparing for disasters, we can save up to \$13 in recovery costs, while protecting homes, jobs, and critical infrastructure.
