Draft Research Questions

Fiscal Health and Sustainability

- Are local governments taking on more services than they have in the past?
- What services are local government assuming that they have not done in the past?
- How are state governments reducing autonomy of local governments?
- How are local governments being limited in lobbying efforts?
- Who decides what services are provided by what levels of government?
- How can local government demonstrate it is an adequate steward of public resources?
- How can local governments justify funding their government at higher levels?
- If government funding is limited, how best do communities prioritize their spending?

Citizen-Governance Disconnect

- How do local governments address the erosion of public trust in government?
- How do local governments help residents better understand how their money is spent?
- What are alternate approaches for local governments to engage residents on issues?
- What are alternate locations for local governments to engage residents on issues?
- How can local governments use AI tools to gather information on social media trends of the community?
- How can we encourage people to participate in local governance?
- How can participatory budgeting initiatives help build trust?
- How can compensation for community participation be a factor in building trust with disadvantaged communities?

Emerging Technology in Local Government

- How do technology companies set standards for technology needs of local governments?
- What expertise do local government use to evaluate new technologies?
- How do technology companies drive innovation in local government instead of being driven by existing problems?
- How do local governments design, select use enterprise resource planning (ERP) systems?
- How do local government managers navigate trade-offs of values in relation to adopting new technologies?

Preemption/State and Federal Impacts

- What are the historical lessons learned from previous state and Federal preemption initiatives?
- How does preemption of authority by state legislatures impact local governments?
- How does preemption of authority by the Federal Government impact local governments?
- How do local governments address preemption of authority on broadband access?
- How do local governments address preemption of authority on taxation?
- How do local governments address preemption of authority on diversity, equity and inclusion programs?

- What are the definitions today of preemption versus home rule?
- What are the political implications of preemption?
- How are state governments using efficiency commissions using preemption to promote efficiency?

Recruitment and Retention of Employees

- What are the effects of local government residency requirements specifically for city managers?
- Do flexible work arrangements actually have a benefit to attracting and retaining talent?
- Do procurement policies that have equity-based goals actually achieve those goals?
- What impacts can still be achieved in DEIA despite the microscope they're under right now?
- What are the organizational benefits on having a succession plan in place versus no succession plan?
- What benefits have there been in incorporating alternative response mental health providers in the overall recruitment and retention of police officers?
- What have local governments done to develop successful recruitment campaigns messaging around public service careers?
