### **Project Overview**

## Artificial Intelligence's Impact on Municipal Economies

Background: When the Grand Challenges in Public Administration were announced in November 2019, the Academy identified Make Government Artificial Intelligence (AI) Ready as a key public administration challenge for the nation. Recent progress in AI transforms entire sectors, advances new industries, and fosters new economic activity; it also, however, raises concerns about bias, security, transparency, and budget and procurement processes. Municipal economies that wish to leverage AI's potential and proactively avoid falling behind must solve these issues while limiting negative impacts on growth. This study will investigate both the overall impact of AI on municipal economies and the steps local, state, and federally focused state programs can take to proactively navigate the AI transition.

## **Project Description**

The Academy Study Team will support Google by conducting a twelve-month, detailed examination of the impact that AI has on municipal economies. This project is designed to comprehensively analyze AI's benefits and challenges and deliver an actionable and clear framework to local governments. Phase one will include detailed Case Studies. Phase two will include a Public Policy White Paper and Municipal Economy Readiness Framework. Phase three will focus on public engagement and report dissemination.

The Academy has appointed a five-member Expert Advisory Group (EAG) to oversee and guide this study. Information on the EAG and Study Team is provided on the next page. A final report with findings and executive briefings on the report will be completed by November 30, 2025.

He received decorations from the governments of Bolivia and Peru, and taught at the American University in Cairo, The London School of Economics, and the Universidad Católica Argentina. A citizen of Argentina, Italy and the USA, he holds a PhD and a MSc in Economics from The London School of Economics, and a Summa-Cum-Laude BA in Economics from Universidad Católica Argentina.

Nick Hart's career reflects a dynamic engagement with evidence-informed policymaking and data advocacy. Mr. Hart is currently President & CEO of the Data Foundation, championing data-driven approaches to governance and the use of data. Previously, Mr. Hart directed the Evidence Project at the Bipartisan Policy Center from 2017 to 2019, where he remains a Fellow. As Policy and Research Director of the U.S. Commission on Evidence-Based Policymaking from 2016 to 2017, he helped formulate unanimous recommendations that became the basis of the Foundations for EvidenceBased Policymaking Act (Evidence Act). His service in government included roles as a Senior Program Examiner within the White House Office of Management and Budget, focusing on education, income maintenance, and labor programs from 2012 to 2017, as a Special Assistant from 2011 to 2012, and as a Program Examiner for natural resources programs from 2009 to 2011. Mr. Hart is an Adjunct Professor at George Washington University's Trachtenberg School of Public Policy and Public Administration in program evaluation.
