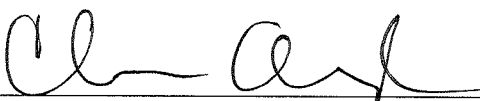

The State shall not be required to transfer funds from any other account or source in the event funds are reduced or unavailable.

6.
