Sales and Purchase Tax will be charged, if required under your State Statute. Leases for Contractor's equipment are available through two (2) third-party leasing companies, PNC Equipment Finance and Municipal Asset Management, Inc.

- b. Subcontractors: All contractors, dealers, and resellers authorized in the State of Maryland, as shown on the dedicated Contractor (cooperative contract) website, are approved to provide sales and service support to participants in the NASPO Master Agreement.
- c. Orders: Any order placed by a Participating Entity or Purchasing Entity for a product and/or service available under the Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions of) the Master Agreement unless the parties to the order agree, in writing, that another contract or agreement applies to such order.

All Purchase Orders issued by purchasing entities within the jurisdiction of this Addendum must include the following Mandatory Language:

- d. Individual Customer: Each State agency and political subdivision, as a NASPO Member, that purchases products/services under this Participating Addendum will be treated as if they were Individual Customers. Except to the extent modified by a Participating Addendum, each agency and political subdivision will be responsible to follow the terms and conditions of the Participating Addendum and the NASPO Contract. Each agency and political subdivision will be responsible for their own charges, fees and liabilities. Each agency and political subdivision will have the same rights to any indemnity or to recover any costs allowed in the contract for their purchases. The contractor will apply the charges to each NASPO Member individually.
 - e. Software license terms and conditions shall be mutually agreed upon in writing by the Purchasing Entity's authorized individual and Contractor.
