The State of Oregon ("Participating Entity") acting by and through the Department of Administrative Services, Procurement Services ("DAS PS") and Falcon Road Maintenance Equipment, LLC. ("Contractor") hereby enter into this Participating Addendum ("PA") . The PA incorporates all terms, conditions, and requirements of the Master Agreement that apply to a *Participating Entity or Purchasing Entity*, except as *specifically modified as set forth in Paragraph 3, below*. DAS PS and Contractor may be referred to as "Party" or "Parties".

1. **Participation:** This PA may be used by the Participating Entity and all entities authorized by state statutes and other laws and regulations to utilize Participating Entity's contracts, or as otherwise authorized in writing by the Participating Entity's chief procurement officer (individually "Purchasing Entity"). DAS PS and Contractor are the Parties to this PA. Purchasing Entities are intended beneficiaries of this PA.
2. **Term:** This PA becomes effective upon execution ("Effective Date") and will remain in place until expiration or termination of the Master Agreement (including extensions and renewals thereof), unless terminated earlier in accordance with the terms of this PA and the Master Agreement. All amendments, if any, to the Master Agreements entered into between the Lead State and Contractor are automatically incorporated into this PA.
3. **Modifications:** Any additions or modifications to the Master Agreement that have been negotiated and agreed to by the Parties to this PA are set forth in Exhibits 1 through 4 attached to this PA and will have no effect on the Master Agreement as it applies to other Participating Entities.
4. **Approval:** DAS PS certifies it has obtained all necessary approvals required by the Master Agreement and PA and has the authority to enter into this PA.

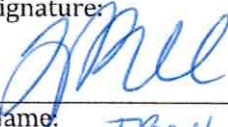
