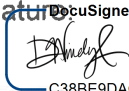
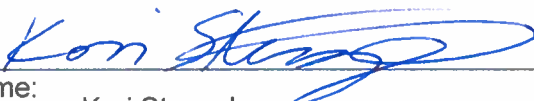
1. Scope: This addendum covers Formula Rebates for Women, Infants and Children (WIC) led by the State of Kansas for use by state agencies and other entities located in the State of Utah authorized by that State's statutes to utilize State contracts with the prior approval of the State's Chief Procurement Official. An amendment to this PA is not required when offerings are adjusted in the Master Agreement, so long as all additions remain within the master agreement's original scope.
2. Pricing: The pricing and rates from the Master Agreement shall flow down to this PA. An amendment to this PA is not required when pricing in the Master Agreement is adjusted / updated.
3. Administrative Fee: 0% and will apply per Section 35 of Attachment A.
4. Contract Effective Dates: This PA is effective upon final signature of both parties, and expires upon the expiration or termination of the WIC Infant Formula Rebate. A contract amendment is not necessary in the event of the renewal or extension of the Master Agreement, so long as such renewal/extension was originally provided within the solicitation supporting the master agreement.
5. Order of Precedence:
As stated in the master agreement #56283
6. Participation: This WIC Infant Formula Rebate Master Agreement may be used by entities that meet both the following:
 - a. A WIC eligible entity; and
 - b. Eligible to use Utah Cooperative Contracts under Utah Code 63G-6a-2105
