2. - C. The State of Wisconsin's Participating Addendum will be governed by the Master Agreement and the State of Wisconsin's additional terms and conditions.
- D. The State of Wisconsin Standard Terms and Conditions shall prevail if there is a conflict between Wisconsin's and NASPO ValuePoint's Terms and Conditions.
- E. The Contractor must sign and include the Cooperative Purchasing Agreement to allow municipalities, as defined on the Agreement, to purchase through this addendum. (Attachment 2)
- F. This Participating Addendum shall be effective upon approval by Wisconsin's Department of Administration and shall continue until the end date of the NASPO ValuePoint contract. NASPO ValuePoint amendments to renew the term date are automatically incorporated into this Participating Addendum unless terminated early in accordance with the terms and conditions of the NASPO ValuePoint contract or this Participating Addendum.
- G. The State of Wisconsin, Department of Administration may terminate this contract at any time upon 60-day prior written notice. Upon termination or other expiration of this contract, each party shall assist the other party in orderly termination of the contract and the transfer of all assets, tangible and intangible, as may facilitate the orderly, non-disrupted business continuation of each party. This provision shall not relieve the

contractor of the obligation to perform under any purchase order or other similar ordering document executed prior to termination becoming effective.

- H. Contractor must submit, on a quarterly basis, an itemized purchasing activity report that captures the Participating State's equipment purchases within the quarter. The report must include, at a minimum, Order date, Order Number/Purchase Order Number, Name of the purchasing entity, Manufacturer Part Number, Item Description, Unit of Measure, Quantity Ordered, Unit List Price, Extended List Price, Additional Shipping/Delivery costs if applicable.

The activity report is due no later than 30 calendar days after the end of each quarter from the

start of the contract date (see below).

o Quarter 1: January 1 through March 31 (Due on or before April 15)

o Quarter 2: April 1 through June 30 (Due on or before July 15)

o Quarter 3: July 1 through September 31 (Due on or before October 15)

o Quarter 4: October 1 through December 31 (Due on or before January 15)

o Reports must be emailed to State of Wisconsin, Dept. of Enterprise Operations,

5. Lease Agreements: **Lease Agreements Are NOT Authorized by this Contract.**

6. Subcontractors: All contactors, dealers, and resellers authorized in the State of *Wisconsin*, as shown on the dedicated Contractor (cooperative contract) website, are approved to provide sales and service support to participants in the NASPO ValuePoint Master Agreement. The contractor's dealer participation will be in accordance with the terms and conditions set forth in the aforementioned Master Agreement.

7. Orders: Any order placed by a Participating Entity or Purchasing Entity for a product and/or service available from this Master Agreement shall be deemed to be a sale under (and governed by the prices and other terms and conditions) of the Master Agreement unless the parties to the order agree in writing that another contract or agreement applies to such order. All orders issued by purchasing entities within the State of Wisconsin must include the Participating State contract number: 505ENT-O25-POLICERADAR-03 as well as the Lead State Master Agreement number 24823.
