2. Participation: This Participating Addendum may be used by all state agencies, institutions of higher institution, political subdivisions and other entities authorized to use statewide contracts in the State of Wisconsin (collectively "Purchasing Entities"). Issues of interpretation and eligibility for participation are solely within the authority of the State Chief Procurement Official.

4.1 The Wisconsin contract number for this Participating Addendum is 505ENT-M24-OFFURNITUR-02.

4.2 The State of Wisconsin Standard Terms and Conditions (DOA-3054A, revised R03/2019) as attached become part of this Participating Addendum. (Attachment 1).

4.3 The State of Wisconsin's Participating Addendum will be governed by the Master Agreement and the State of Wisconsin's additional terms and conditions.

4.4 Except as otherwise may be provided in this Participating Addendum, the State of Wisconsin Standard Terms and Conditions shall prevail if there is a conflict between Wisconsin's and NASPO ValuePoint's Terms and Conditions.

4.5 The Contractor must sign and include the Cooperative Purchasing Agreement (DOA-3333, revised R05/2015) to allow municipalities, as defined on the Agreement, to purchase through this addendum (Attachment 2).

4.6 Contractor must submit, on a quarterly basis, an itemized purchasing activity report that captures the purchases within the quarter from State of Wisconsin entities and participating municipalities. The report must include, at a minimum: purchasing entity, product category description (For example, Category #1: Office Seating and Accessories), date of purchase, contract price, retail price, the extended price for each transaction, and additional shipping/delivery costs, if applicable. These reports are due 30 days after the end of the quarter. Additional lines at the end of the report will detail each quarter and year to date total contract spend.

The activity report is due no later than 30 calendar days after the end of each quarter from the

start of the contract date (see below).

- o Quarter 1: January 1 through March 31 (Due on or before April 30)
- o Quarter 2: April 1 through June 30 (Due on or before July 30)
- o Quarter 3: July 1 through September 31 (Due on or before October 30)
- o Quarter 4: October 1 through December 31 (Due on or before January 30)
- o Reports must be emailed to State of Wisconsin, Dept. of Enterprise Operations,
Attn: DOAESContractUsageReporting@wisconsin.gov

4.7 Either party may terminate this Participating Addendum at any time upon 30-day prior written notice to the other party. Upon termination or other expiration of this Participating Addendum, each party shall assist the other party in orderly termination of the contract and the transfer of all assets, tangible and intangible, as may facilitate the orderly, non-disrupted business continuation of each party. This provision shall not relieve the Contractor of the obligation to perform, or the Purchasing Entity's obligation to pay outstanding invoices and for work in progress, under any purchase order or other similar ordering document executed prior to termination becoming effective.

4.8 This Participating Addendum shall be effective upon approval by Wisconsin's Department of Administration and shall continue until the end of the NASPO ValuePoint Master Agreement unless terminated early in accordance with the terms and conditions of the NASPO ValuePoint contract or this Participating Addendum.

5. Subcontractors: All contractors, dealers, and resellers authorized in the State of Wisconsin, as shown on the dedicated Contractor (cooperative contract) website, are approved to provide sales and service support to participants under this Participating Addendum as outlined in the NASPO ValuePoint Master Agreement. The Contractor's dealer participation will be in accordance with the terms and conditions set forth in the aforementioned Master Agreement.
6. Orders: Any order placed by a Participating Entity or Purchasing Entity directly through Contractor or authorized dealer for a product and/or service available from this Participating Addendum shall be deemed to be a sale under (and governed by the prices and other terms and conditions) of the Master Agreement unless the parties to the order agree in writing that another contract or agreement applies to such order.
7. Design, Installation, Layout, and Reconfiguration Services: The Contractor shall offer, through its authorized dealers, design, installation, layout, and reconfiguration services to Purchasing Entities. Charges for all services offered through this Participating Addendum

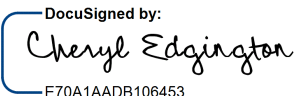

will be negotiated on a project-by-project basis with the authorized dealer and included as a line item in the quote provided by the authorized dealer. Contractor may offer, through its authorized dealers or approved freight carrier(s), liftgate services and other non-standard delivery services which are outside of Contractor's standard freight costs, such as palletization, storage, special permits, etc. Should Contractor be able to offer such non-standard delivery services, these services will be negotiated on a project-by-project basis and approved by the Purchasing Entity. Charges for non-standard delivery services will be included as a line item in the quote provided by the authorized dealer.

8. Pricing: Notwithstanding anything contained herein to the contrary, products, list prices, and discounts under this Participating Addendum follow the NASPO ValuePoint Master Agreement MA3963.
9. Amendments: Amendments to the NASPO ValuePoint Master Agreement (included but not limited to extensions, renewals, and modifications to the terms and conditions including products and pricing) will automatically be incorporated into this Participating Addendum without the need to formally amend this Participating Addendum.
