

## Disaster and Emergency Contacts—Oregon

(Updated 7/1/2021)

The local health departments (LHDs) have responsibility for the emergency preparedness and response activities in their respective counties. LHDs will coordinate Emergency Support Function #8 (ESF8) incidents and requests through the county Emergency Operations Center (EOC). The county EOC will then submit requests to the state Emergency Coordination Center (ECC). When all internal and external partner-based options to obtain PPE supplies or medical resources have been exhausted, then contact your local public health department for additional resources. Oregon Health Preparedness Organization (HPO) coordinates works with county and regional partners to prepared and respond to large-scale health emergencies.
