

International Marine Terminal Contacts

Have questions regarding your international container shipment? Get to know The Northwest Seaport Alliance International Marine Terminal Operators.

Information available to you online:

- **Empty containers:** Drop-off/Pick-up locations and updates specific to ocean carrier empty receiving
- **Export receiving:** Schedule for first receiving and cutoff dates for dry/reefer, by vessel and service
- **Chassis:** Participating pools, availability, roadability requirements and updates specific to ocean carrier equipment
- **Scheduling:** Import container availability and appointments, and pre-arrival for export/empty containers
- **Vessel schedules:** Estimated times of arrival and departure
- **Peel-off delivery:** Peel-off program qualifications and benefits to participating
- **Terminal gates:** Gate cameras, schedules, transaction and gate tickets
- **Payments:** Convenient payment options for demurrage and exam fees, view your payment history
- **Other Resources:** Crane row locations, Firm codes, Hazardous paperwork, roadability rules, trucker registration
