the costs of the services of the factfinding panel chairperson, including per diem fees and actual and necessary travel and subsistence. Prior Board action set the rate for factfinding services at \$1,100 per day with a four-day contract maximum. The Board will review the current factfinding policy for compensating factfinding panel chairpersons annually for potential modification.

- E. Regulations on Filing Requirements: Consideration of approval for submitting a proposed rulemaking package to the Office of Administrative Law in order to initiate the formal rulemaking process to revise existing regulations governing filings. If authorized by the Board, the rulemaking package, including Notice of Proposed Rulemaking, Proposed Text, and Initial Statement of Reasons, will be forwarded to the Office of Administrative Law for review and publication pursuant to the Administrative Procedures Act. In addition, the Notice of Proposed Rulemaking would be distributed by PERB to interested parties and posted on the PERB website.
- F. PERB Records Retention Schedule: Consideration for approval of changes to PERB's record retention schedule (which is filed with the California Secretary of State) to denote that the Board itself has authorized the retention periods that are not set by statute or regulation. If approved by the Board, the proposed amendments would not change the existing record destruction periods, but would clarify that the periods have Board approval.
